A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 3, 2025 FOR THE PURPOSE OF ELECTING ONE COUNCILMEMBER FOR PLACE 1 – WARD 1; ONE COUNCILMEMBER FOR PLACE 3 – WARD 3; ONE COUNCILMEMBER FOR PLACE 5 – AT LARGE; AND ONE COUNCILMEMBER FOR PLACE 6 – AT LARGE TO THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS EACH FOR A FOUR YEAR TERM

WHEREAS, at a special meeting of the City Council of the City of Brenham, Texas, held at the regular meeting place in City Hall located at 200 West Vulcan Street, Brenham, Texas on the 13th day of May, A.D., 2025, a quorum being present, there came on to be considered the returns of the general election held on May 3, 2025 for the purpose of electing one councilmember for Place 1 – Ward 1; one councilmember for Place 3 – Ward 3; one councilmember for Place 5 – At Large; and one councilmember for Place 6 – At Large to the City Council of the City of Brenham, Texas, each for a four year term ending May, 2029; and

WHEREAS, under and by virtue of the general election order duly enacted and approved by the City Council of said City on the 23rd day of January 2025, and thereafter duly published as required by law and for the time and in the manner provided by State statute and the City Charter, said general election was duly and legally held and conducted in the said City on the 3rd day of May, A.D., 2025;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS THAT:

SUMMARY STATEMENT:

As required by law, this item is to canvass the returns and declare the results of the Special Election held on May 3, 2025. The Special Election was for the purpose of submitting twelve (12) proposed amendments to the City's Home Rule Charter. The results of the Special Election indicate that all twelve (12) propositions were approved by the voters.

RECOMMENDATION:

Approve Resolution No. R-25-016 canvassing the returns and declaring the results for the Special Election held on May 3, 2025 at which were submitted twelve proposed amendments to the City of Brenham's Home Rule Charter.

RESOLUTION NO. R-25-016

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD ON MAY 3, 2025 FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF BRENHAM, TEXAS TWELVE (12) PROPOSED AMENDMENTS TO THE CITY'S HOME RULE CHARTER; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on February 6, 2025 the Brenham City Council adopted Ordinance No. O-25-001 ordering a Special Election to be held on May 3, 2025 for the purpose of submitting twelve (12) propositions to the qualified voters of Brenham, Texas for proposed amendments to the existing Home Rule Charter of the City; and

WHEREAS, on April 17, 2025 the Brenham City Council adopted Ordinance No. O-25-004 correcting the dates of Early Voting for the Special Election to be held on May 3, 2025; and

WHEREAS, at a special meeting of the City Council of the City of Brenham, Texas, held at the regular meeting place in City Hall located at 200 West Vulcan Street, Brenham, Texas on the 13th day of May, A.D., 2025, a quorum being present, there came to be considered the returns of the special election held on May 3, 2025 for the purposes of canvassing said special election, declaring the results of said special election, and declaring that each Proposition for which a majority of the qualified voters voting in said special election voted "Yes" has been approved by such voters, and that such amendments shall become a part of the City's Home Rule Charter;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRENHAM, TEXAS:

SECTION 1.

The Special Election of May 3, 2025 was duly called, notice of the election was given in accordance with law, and the election was held in accordance with law.

SECTION 2.

The tabulation of votes cast in the Special Election held on May 3, 2025, a copy of which is attached hereto as Exhibit "A" and made a part of this Resolution for all pertinent purposes, is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the City of Brenham as the official canvass of the election.

SECTION 3.

The official canvass of the returns of the special election reflects the following votes were cast for and against the twelve (12) propositions:

PROPOSITION A

Shall Article I, Section 2; Article II, Sections 1, 2 and 8; Article III, Sections 8, 15, 17, 18, 19, 21, 23 and 24; Article IV, Sections 1, 2, 3 and 8; Article V, Sections 1, 2, 3 and 4; Article VI, Sections 3, 6, 9, 11 and 15-19; and Article VII, Sections 6, 12, 14, 15, 19 and 24 of the Brenham City Charter be amended by 1) making corrections to grammar, spelling and punctuation errors; 2) deleting reserved sections of the Charter throughout all Articles of the Charter and renumbering the sections due to deletions and other revisions as necessitated by other propositions on this ballot that are approved by the voters; and 3) making non-substantive vocabulary changes in order to use modern and consistent terminology, titles, and labels, which shall include but not be limited to, changing the references to members of the governing body from "governing authority" to "City Council"?

Votes for Proposition A: 1,157 Votes against Proposition A: 183

PROPOSITION B

Shall Article I, Section 2 of the Brenham City Charter be amended by clarifying the authority, procedures and terminology concerning annexation and disannexation of territory to be consistent with applicable federal, state or other law?

Votes for Proposition B: 1,155 Votes against Proposition B: 177

PROPOSITION C

Shall Article III, Section 4 of the Brenham City Charter be amended by providing that a person may not serve as Mayor more than three (3) consecutive elected four (4) year terms of office; providing that after completing three (3) consecutive elected terms of office, a person may again serve in the office of Mayor after one (1) entire year of not holding the office of Mayor; providing that a person shall not serve as a Councilmember, either in a ward or at-large, more than three (3) consecutive elected four (4) year terms of office, or twelve (12) consecutive years; providing that after completing three (3) consecutive elected terms of office, or twelve (12) consecutive years, a person may again serve in the office of Councilmember after one (1) entire year of not holding the office of Councilmember; providing that time served by appointment or by election to fill a vacancy in the office of Mayor or Councilmember for an unexpired term shall not count toward the term limit; and providing that terms of office, or partial terms of office, served as Mayor or Councilmember prior to May 3, 2025 shall not be considered for the purpose of term limits?

Votes for Proposition C: 1,151 Votes against Proposition C: 198

PROPOSITION D

Shall Article III, Section 6 of the Brenham City Charter be amended by clarifying the qualifications necessary to hold the office of Mayor and Councilmember; clarifying that any Mayor or Councilmember that ceases to possess any of the required qualifications shall automatically forfeit his office; and deleting provisions related to conflicts of interest?

Votes for Proposition D: 1,155 Votes against Proposition D: 207

PROPOSITION E

Shall Article III, Section 8 of the Brenham City Charter be amended by clarifying that members of the City Council do not serve as Election Judges, as that position is defined in Chapter 32 of the Texas Election Code, in any election held by the City?

Votes for Proposition E: 1,246 Votes against Proposition E: 112

PROPOSITION F

Shall Article III, Sections 9 and 11 of the Brenham City Charter be amended by providing that the regular municipal elections of the City shall be held on the uniform election date in May of odd-numbered years, or on any other uniform election date authorized by law?

Votes for Proposition F: 1,209 Votes against Proposition F: 124

PROPOSITION G

Shall Article III, Section 10 of the Brenham City Charter be amended by providing that all City Council runoff elections shall be held in accordance with applicable law?

Votes for Proposition G: 1,268 Votes against Proposition G: 91

PROPOSITION H

Shall Article III, Section 13 of the Brenham City Charter be amended by providing that the City Council shall meet within fourteen (14) days after an election, whether a regular election or runoff election, at which time Councilmembers-elect shall qualify and assume the duties of their offices?

Votes for Proposition H: 1,236 Votes against Proposition H: 114

PROPOSITION I

Shall Article III, Section 14 of the Brenham City Charter be amended by providing that the Mayor's salary shall be changed from two hundred seventy-five dollars (\$275.00) per month to five hundred fifty dollars (\$550.00) per month, and each Councilmember's salary shall be changed from two hundred twenty-five dollars (\$225.00) per month to four hundred fifty dollars (\$450.00) per month?

Votes for Proposition I: 777
Votes against Proposition I: 572

PROPOSITION J

Shall Article III, Section 23 of the Brenham City Charter be amended by requiring the Mayor, City Councilmembers and other officers and employees of the City, with regard to any contract or other matter authorized by the City, to comply with the Texas Local Government Code and all other applicable laws governing conflicts of interest of local public officials?

Votes for Proposition J: 1,236 Votes against Proposition J: 118

PROPOSITION K

Shall Article VII, Section 7 of the Brenham City Charter be amended by providing that with regard to official bonds of certain officers of the City, the City Manager, rather than the City Council, shall determine the amounts of and approve said bonds?

Votes for Proposition K: 731 Votes against Proposition K: 588

PROPOSITION L

Shall Article IV, Section 1 of the Brenham City Charter be amended by providing that the City Manager shall establish his residence within Washington County, Texas as directed by the City Council?

Votes for Proposition L: 1,199 Votes against Proposition L: 175

SECTION 4.

That the City Council hereby finds and determines, as a result of this canvass, that a total of 3,528 persons voted in the Special Election concerning proposed amendments to the City Charter held on May 3, 2025. The City Council further finds, determines, and declares that there were no Propositions not approved by a majority of the qualified voters. The City Council further finds, determines, and declares that Propositions A, B, C, D, E, F, G, H, I, J, K and L each received a majority vote in favor of adoption of such Proposition, and were approved by a majority of qualified voters. Accordingly, the City Council hereby orders that the amendments to the City's Home Rule Charter as set forth in Propositions A, B, C, D, E, F, G, H, I, J, K and L shall become a part of the City's Home Rule Charter in accordance with the provisions of Texas Local Government Code Section 9.005.

SECTION 5.

That Amendments to the City Charter set forth in Propositions A, B, C, D, E, F, G, H, I, J, K and L, having been approved by a majority of the votes cast in the election, are hereby declared to be adopted and to be a part of the City's Home Rule Charter from and after such adoption.

SECTION 6.

That the Mayor and the City Secretary, and any other officers and employees of the City of Brenham, Texas required to take any action as a result of the adoption of the amendments to the City's Home Rule Charter as herein provided for, are hereby authorized and directed to take any and all such actions.

SECTION 7. EFFECTIVE DATE

This Resolution shall become effective immediately upon adoption.
