3. Approve the Minutes from the February 10, 2026, Brenham Police Department Citizens Advisory Board Meeting

WORK SESSION

4. Discussion on Brenham Police Department's 100-year Anniversary Celebration

Bob Cox announced that Washington County Cares has sold 180 seats for the fundraiser; 30 seats will be for officers and family. The meal will be catered by Lone Star Grill. Again, the fundraiser will be held May 7, 2026, beginning at 11:30am at the Washington County Event Center. Funding raised will be used towards officers' wellness performance & readiness program and support of mental & spiritual health.

5. Discussion and Presentation on the Brenham Police Department's Statistics for January and February 2026

Chief presented the January and February patrol and performance statistics for the Brenham Police Department. Officers were busy for the 1st 3 months of the year; more CFS (call for service) and traffic stops. The number of motor vehicle collisions has increased since last year.

6. Administrative Updates

Chief stated that he hopes to see an increase in automated LPR readers in the area due to grants being offered. The LPR cameras automate license plate checks and sends it to the officer; it checks Amber Alerts, stolen vehicles, wanted persons, to name a few. There is a misconception that LPR's track vehicles every location and/or movement; the LPR's do mass surveillance. The 3 cadets attending the TEEEX Police Academy will have graduation June 11, 2026. The department had 1 cadet start April 13, 2026, with graduation being September 2026. Recruiting has opened to try finding 2-3 individuals to send to the Academy. Cpl. Gibbs will be transitioning into the Community Engagement Officer (CEO) position; Cpl. Crosby will take Gibbs' place at the schools as School Resource Officer (SRO). The Criminal Investigative Division (CID) is doing online training for crimes against children with the focus of training to catch predators in our community. Detective Morong spoke at the Senior Center about fraud. Fraud cases have increased, not only with the elderly. Morong would love to speak to groups about this topic; please reach out to PD if you are interested.

It was announced the next CAB meeting will take place on June 9, 2026.
