4. Discussion and Update on Police Department and Staffing/Training

Asst. Chief Powell stated that the department is down five officers. He said that he will be meeting with City Hall to discuss increasing the starting pay to be more competitive. Powell explained that it is not like it used to be, the days of long-term employment are gone – most officers are looking at higher pay and that is it.

Bryan Police Department has been extremely gracious and offered the department two open spots in their police academy at no charge. Command Staff will be looking for several candidates to send, which will begin April 5th.

As far as budget and fleet vehicles are concerned, PD cannot get any Chevrolet Tahoe's. The department would like to remain consistent and have all the patrol fleet as Tahoe's but there are none to be found. Dodge Durango's and Ford pickups will be ordered for CID and Admin; Command Staff will turn their Tahoe's over to patrol and take a Durango; the pickups will go to CID and Admin.
