WORK SESSION

3. Discussion and Update on the Brenham Family Park Notice to Proceed from Texas Parks and Wildlife

Public Works Director Dane Rau started this discussion. Dane presented map & update on Jackson Street and notice to proceed. As you all know it has been a long-awaited period for the City of Brenham to get notice to proceed on the Brenham Family Park Project. We now have the contract in our hands to sign and are ready to make this a reality for Brenham.

Over the last 3 years, while we were waiting on clearance from Texas Parks and Wildlife and the National Parks Service, we began design of Phase 1 in order to meet our grant elements as it pertains to the amenities that will go into the park. We also

earmarked additional funds through BCDC (sales tax revenues) knowing that \$750,000 would not go far when you consider an amenity/retention pond, parking, signage, utility extensions, a restroom facility, 1-mile walking/biking trail, lighting, benches, pedestrian bridge, and wildflower areas. During that time BCDC has allocated an additional \$1,015,148 to help get this project started and off the ground. This brings the total available funds to \$1,7651,48 to get started for Phase 1.

Action Items Moving Forward

We will be presenting this item to the City Council in January for authorization to move forward with the \$750,000 grant from Texas Parks and Wildlife. We will then work with Quiddity Engineering to meet the grant elements yet give the City some options to consider when it deals with the current funds allocated toward this project. The contract states that the project needs to be completed by May of 2027. TP&W also allows the recipient to extend projects up to an additional 2 years to meet final construction.

We will work strategically with Quiddity as we prepare the bid in Spring of 2025. We will also reference the Facility Naming Rights Policy as we move through this project. If there is any interest from the public or any members of the community, please have them contact a board member, council member, or City of Brenham Parks and Recreation official.

6. Discuss and Possibly Act Upon New Rates for 2025 Parks and Recreation Facilities and Programs, Including the Blue Bell Aquatic Center

Casey Redman started this discussion. Per Chapter 19, Parks and Recreation, of the Code of Ordinances of the City of Brenham fees for all parks and recreation activities shall be set by resolution of the City Council. Each year rates are evaluated and brought to Parks Board for consideration.

WORK SESSION

4. Discussion and Update Regarding Request for Proposals to Jackson Street Park Phase I Improvements

Public Works Director Dane Rau started this discussion. On February 4, 2025, the City of Brenham along with Burditt Architectural opened a request for proposals regarding the Jackson Street Park Phase 1 Improvements. The scope of work consisted of bringing the entire park up to ADA specifications, enhancement of one restroom facility, adding a new playscape and swing set, upgrading all electrical throughout the park which consist of the walking trail, field lighting, and low-level lighting under the trees and sidewalk extensions. It also includes an additional 4 courts for pickleball.

Within the last two years BCDC has allocated \$1.2 M dollars toward Phase I. With engineering costs, geotechnical reports, and paying for the playground/swing set already that left us with slightly over \$925,000 for the rest of the amenities that we wish to add.

We had a total of 8 companies send proposals for the work, in which all proposals were very complete but overall were over the \$1M mark. The lowest proposal was from DL Meachum at \$1,145,690 with an alternate of \$35,270 for the shade covers for the new pickleball courts. Other bids ranged from \$1.17M, \$1.205M, \$1.26M, \$1.35M and upwards. This leaves us about \$215,000 short.

Next week we will sit down with our finance team along with our administration and see how we would like to proceed. There is an opportunity to award the proposal and then work with the chosen company to value engineering some elements out. We will also take this time to vet the two lowest companies.

If you have any input, we would like to hear those and since there was a base bid and one alternative we will reach out and get a breakout of the specific values to consider. We will work hard to find a way to get this project off the ground and start on these improvements soon.

5. Discussion and Update on Parks and Recreation Projects Funded in 2024-25

Public Works Director Dane Rau started this discussion. We wanted to give you all an update on our 2024-25 funded projects and how they were going as it relates to timing and costs. In the table below you will see how well we have moved these forward and the costs associated with each. By your support along with BCDC this funding allows us to

keep up with our maintenance in the Parks System and at the Aquatic Center. We strive to keep our parks in great shape and are proud of what we have!

Subject: Discuss and Possibly Act Upon a Recommendation to Brenham Community Development Corporation (BCDC) Related to Parks and Recreation projects for fiscal year 2025-26

Date: June 6, 2025

Each year, the Parks and Recreation Staff presents and recommends projects to both the Parks Board and the Brenham Community Development Corporation (BCDC) for input and potential funding respectively. These funds are derived from local sales tax proceeds and are used to enhance parks, recreation, and aquatic amenities throughout the community.

Our goal is to strike a balance between new, innovative additions and the ongoing maintenance and revitalization of existing infrastructure. We also align our project recommendations with the adopted Parks, Recreation, and Open Spaces Master Plan to the greatest extent possible.

For FY25-26, due to a reduction in overall sales tax revenues and the reallocation split with 401(B) Sales Tax, available funding has decreased from a typical \$1.2 million to approximately \$900,000.

FY25-26 Project Funding Options

We are presenting two funding scenarios for consideration:

Option 1 – Allocate \$500,000 to Brenham Family Park

This option prioritizes funding toward Brenham Family Park (BFP) to move the project toward construction by late 2025 or early 2026. With this option, the remaining \$400,000 is allocated across a limited number of high-priority parks and aquatics projects.

- Brenham Family Park – \$500,000
- Parks Projects:
 - Fink/Korthaurer Field Light Upgrades – \$275,000

- Master Turf Infield Rehabilitation – \$35,000
- **Aquatics Projects:**
 - Leisure Pool Float Rehabilitation – \$40,000
 - Slide Tower Repairs – \$27,000
 - Parking Lot Light Replacement – \$29,000
- **Total: \$906,000**

This option continues the city’s momentum toward the development of BFP, which is currently funded with \$1 million from BCDC and \$750,000 from a Texas Parks & Wildlife (TP&W) grant. Phase 1 construction is estimated at \$2.6 million, meaning we still need to secure approximately \$350,000 to meet minimum grant match requirements.

Option 2 – No Allocation to Brenham Family Park

This alternative redirects all available funds to existing parks and aquatic facilities, resulting in a broader reach of improvements across the system but delaying progress on BFP.

- Parks Projects: 4 projects funded
 - Fink/Korthaurer Field Light Upgrades – \$275,000
 - Master Turf Infield Rehabilitation – \$35,000
 - Fireman’s Re-Level and Sod (Infield and Outfield) - \$295,000
 - Fireman’s Park Playground Replacement- \$120,000
-
- Aquatics Projects: 5 projects funded
 - Leisure Pool Float Rehabilitation – \$40,000
 - Slide Tower Repairs – \$27,000
 - Parking Lot Light Replacement – \$29,000
 - BBAC Concession Stand Refurbishment- \$50,000
 - BBAC Banana Split Slide Refurbishment- \$20,000
- No funding allocated to Brenham Family Park

While this option allows us to address more immediate needs, it risks delaying or jeopardizing BFP’s Phase 1 development timeline and grant requirements due to the current funding gap.

Recommendation

Given the funding challenges and the importance of initiating construction of Brenham Family Park to leverage existing grant dollars, staff recommends Option 1. While it limits the number of other projects we can pursue in FY25-26, it strategically invests in a major community asset with long-term impact.
