The City of Brenham has received positive news from Texas Parks and Wildlife concerning the Brenham Family Park Grant from 2020. After many many studies, reports, environmental assessments and correspondence with both the National Parks Service and Texas Parks and Wildlife we have been told by Texas Parks and Wildlife that they have received the approval to issue a Notice to Proceed to the City of Brenham as it relates to Phase 1 of the Brenham Family Park from the National Parks Service.

We are actively working with Quiddity to finalize the design and meet the grant elements while also getting a better understanding of the overall budget of the development of Phase 1(a). We should receive the notice to proceed within the next 30 days from TP&W and will have from 3-5 yrs. to complete the grant elements that consist of utility improvements, parking, restrooms, walking/bike trail, amenity lake/detention, lighting, wildflower areas, pedestrian bridges and signage.

When we applied for the grant in 2020 the largest grant amount was \$750,000. We will receive that along with additional funds that were previously earmarked for the Brenham Family Park by BCDC which consists of another \$794,000. This currently gives the city \$1.54 million dollars to start on the Brenham Family Park amenities. With inflation and significant price increases over the last 4 years we know it will take additional funds to get this project off the ground and yet meet the grant elements that were submitted. We are currently working with both Quiddity and Texas Parks and Wildlife to make sure we meet the grant elements yet receive a complete project that all of Brenham can be proud of.

This is the closest we have ever been and now the reality of moving forward to open this park up while finding ways to fund the amenities will be a top priority for staff, the City of Brenham and BCDC. As we go through our funding cycle you will see another \$300,000 dedicated to this park in order to build the fund in anticipation of going out to bid sooner than later. We would like to have a discussion with BCDC and get their input on the timeline, priorities going into construction, and additional resources needed to fulfill grant elements. We do have some time, as once the NTP is sent to the City of Brenham we have 3 yrs. to construct the park with a possibility of an additional 2 yr. extension.

Subject: Proposed BCDC Budget for FY24-25

Date: June 24, 2024

Attached are preliminary budget summaries for the BCDC FY24-25 budget along with memos from each department director detailing their funding requests for the next fiscal year. Highlights of each budget summary are shown below.

Economic Development Budget Summary (Attachment A)

- Budgeted sales tax revenue increased approximately 5% over FY24 projected actuals.
- Per the January 2021 interlocal agreement between the City and Washington County, the Brenham Washington County Development Organization (BWEDO) will continue to contribute \$100,000 annually to Economic Development activities.
- No significant change to the on-going expenditures of debt service, operations, marketing, and Business Park maintenance. After FY25, one payment will remain on the note payable to the City for the purchase of the SWIP IV Gurrech tract.
- Interfund loan repayment #6 of 10 to Recreation side for funds borrowed to construct the detention ponds in FY20.
- An administrative support reimbursement to the City's General Fund for \$6,000 (\$500/month) is budgeted, the same as the prior year.
- An estimated expenditure of \$50,020 is included in the FY25 budget for the second sales tax reimbursement incentive payment to Academy.
- The engineering and design for the Blue Bell Road extension has been re-budgeted in the FY25 budget at \$118,000.
- Current year net revenue available for funding allocations equals \$169,177.
- Economic Development related funding requests total \$77,690.
- If all requests are approved, a balance of \$91,487 will remain in contingency.
- Fund balance reserves for Economic Development are projected to be \$887,826.

Recreation Budget Summary (Attachment B)

- Budgeted sales tax revenue increased approximately 5% over FY24 projected actuals.
- A \$400,000 payment to the City's General Fund for Parks, Recreation & Aquatics operational support has been included in the budget, the same as the prior year.

- An administrative support reimbursement to the City's General Fund for \$6,000 (\$500/month) is budgeted, the same as the prior year.
- Current year net revenue available for funding allocations equals \$1,482,165.
- Funding requests from Aquatics total \$446,000.
- Funding requests from Parks total \$1,031,000.
- Funding requests from Recreation total \$4,000.
- If all requests are approved, a balance of \$1,165 will remain in contingency.
- Fund balance reserves for Recreation are projected to be \$1,307,023.

The Brenham | Washington County Economic Development budget request continues to include the \$100,000 Washington County investment. A few highlights:

#### Real Estate

A big focus for this coming year is to liquidate some of the land that we re-acquired in the Brenham Business Center. I'm working hard to establish relationships with the local Washington County Commercial Real Estate Broker community, which should help us in this effort. I'm hosting the first of regular Commercial Brokers Luncheons on July 17<sup>th</sup>.

#### **Consultant Services**

I've again allotted monies toward hiring a consultant for business attraction services and assistance in identifying targeted industries based on our competitive advantages. I did not execute on this project previously because I wanted to make sure I had stakeholder involvement regarding solid metrics and deliverables. I also wanted to make sure I had an appropriate global view of the entire County and buy-in, which I believe I have now.

#### **Incentives Management**

A great deal of time was spent on incentives management in the previous fiscal year. This included new abatement agreements, existing abatement agreements and other agreements entered into between organizations and the City of Brenham and/or Washington County. I believe great strides have been made to ensure that agreements are audited regularly, and I will continue this practice to ensure accuracy and accountability.

Downtown Brenham is thriving with activity. Main Street Brenham is submitting a request to the Brenham Economic Development Corporation (BCDC) for funding to support two key initiatives aimed at enhancing the economic vitality of our downtown district. Our mission is to strengthen and facilitate the economic development of historic downtown for everyone. We are enthusiastic about these programs with the support of BCDC. Our requests for funding this year include:

#### 1. Incentive Grant Fund Match:

## We are fortunate that both new and long-time property and business owners are planning renovations to historic properties, which will certainly result in increased traffic and sales tax. Main Street uses raised funds from events and programs to offer this grant for façade rehabilitation. This additional funding will allow us to expand the program's reach and support a greater number of façade rehabilitation projects, ultimately leading to a more aesthetically pleasing and economically vibrant downtown.

By freeing up street parking closer to businesses, this initiative will directly benefit local merchants, potentially leading to increased sales tax revenue for the city.

#### 3. Downtown Brenham Website

#### \$7,000

This website will serve as a central hub for information about our vibrant downtown district, promoting its economic success and fostering continued growth. DowntownBrenham.com will showcase the achievements of the Main Street Brenham program, detailing past successes and ongoing initiatives that contribute to the district's economic vitality. The website will also showcase the diverse array of businesses and foster a perception of a thriving district to attract potential customers, investors, and entrepreneurs to our downtown area.

We respectfully request funding of \$70,690 for these much-needed Main Street programs.

Date:	June 19, 2024

Each year, the Parks and Recreation staff is able to present and recommend various projects to both Parks Board and BCDC for funding opportunity. These funds are derived from sales tax proceeds that are spent locally and are geared to enhance Parks and Recreation along with Aquatic amenities. We strive to have a mix of new amenities along with maintenance and upkeep of existing amenities which keeps our Parks System looking fresh and vibrant. We also take in account the Parks Master Plan and follow our goals and projects to the best of our ability.

Below you will see the requests that were brought to the Parks Board for consideration on May 8, 2024. We would like to respectfully ask for BCDC's consideration on the below projects for the 2024-25 funding cycle. There are 14 projects valued at \$1.48 million dollars in this year's requests.

These projects were evaluated by Parks and Recreation Staff and prioritized based on need and future value to our parks system. Due to priority, the budget, and status of existing infrastructure these projects are of our upmost importance. The Parks Board recommended approval of these items pending the allocated budget of BCDC. Discussion was had on the priority and if all items couldn't be funded that a possibility of the roof access and Hohlt Expansion Joint Sealing be pushed back a year. Priority was given regarding the Automatic Back Door and Awning Project for the handicap parking lot.

Our 3 largest requests will be Jackson St Park Phase 2 Improvements (\$500,000), Brenham Family Park Additional Funding (\$300,000), and a Replacement Slide for the Blue Bell Aquatic Center Leisure Pool (\$350,000). All items will be shared in farther detail at the meeting on a slide show.

We respectfully ask BCDC to consider funding these items so that we can move forward with enhancements to our park and recreation facilities.
