The no-new-revenue tax rate is the tax rate for the <u>2021</u> tax year that will raise the same amount of property tax revenue for <u>City of Brenham</u> from the same properties in both the <u>2020</u> tax year and the <u>2021</u> tax year.

The voter-approval rate is the highest tax rate that <u>City of Brenham</u> may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that <u>City of Brenham</u> is proposing to increase property taxes for the <u>2021</u> tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON <u>SEPTEMBER 2, 2021 AT 1:00 P.M.</u> AT <u>CITY HALL, 200 WEST VULCAN STREET, BRENHAM, TEXAS 77833</u>.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, <u>City of Brenham</u> is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting members of the <u>City Council</u> of City of Brenham at their offices or by attending the public hearing mentioned above.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

Property tax amount = (tax rate) x (taxable value of your property) / 100
