
Subject: Surveying and Platting Services

Date: May 18, 2022

At the April 21, 2022 BCDC meeting the Board approved a land swap with the City of Brenham for a 5-acre tract in the Brenham Business Center for a new fire station.

When Jon Hodde began the surveying work for the 5-acre tract, he discovered that Handley Street had never been platted. Therefore, while getting a quote to correct the plat issues with Handley Street, the decision was also made to get a quote for the survey and plat of the northern 6.4 acre tract.

The cost to provide the surveying and platting service is \$11,500 with a +/- contingency of 15% due to the costs of the filing fees and the title report (these will be billed on actual costs).


SCOPE

Boundary Survey and Platting:

Survey and plat a 5.000 acres tract out of the residue of Reserve "E" at the Northeast intersection of James Nutt Boulevard and Handley Street. Survey and plat an approximate 6.4 acres residue tract, adjacent to and North of the 5.000 acres tract. Survey and plat the extension of Handley Street, as it is described by metes and bounds, from where it was extended from the North line of Lot 5, Brenham Business Center, to its intersection with James Nutt Boulevard.

This leaves a residue of Reserve "E" on the Southeast side of Handley Street, adjoining James Nutt Boulevard, to be platted at a later date.

We reviewed information provided by the Client, record data and information we have in house as well as data from the Washington County Appraisal District and Washington County Clerk concerning the subject property. The boundary survey will include, in part, obtaining the current deeds, field notes and plats to the subject property as well as the deeds, field notes and plats to all adjoining tracts, plotting, analyzing and comparing them with the subject deeds for any conflicts, surveying the outer perimeter of the subject property, locating existing perimeter fencing and showing the relation to the actual boundary line and replacing any missing corner monuments and reference points. We will also locate any

visible utilities relative to the subject tract, based on ground evidence and a current Title Report.

We will prepare a preliminary and final subdivision plat of the two lots and portion of Handley Street. Iron rods 5/8 inch in diameter and 24 inches long with Id. caps will be set at all lot corners and points of tangency and curvature along the roadway. The preliminary and final plats will be submitted to the City of Brenham's Development Services Department to be reviewed and subsequently approved. After final approval, we will record the plat in the Plat Records of Washington County, Texas. A current Title Report will be required for platting which will provide information for existing easements and encumbrances.

Conventional surveying methods (GPS and Total Stations) will be used to perform the boundary survey.


The horizontal data will be relative to the Texas State Plane Grid System, NAD-83, Central Zone, US Survey Feet. Elevation values will be relative to NAVD-88 (Geoid 18) datum based on an NGS OPUS solution.

Platting the residue of Reserve "E" on the Southeast side of Handley Street, adjoining James Nutt Boulevard, topographic surveying services and engineering services are not included in this proposal. If these services are needed, we would be happy to provide a separate proposal.

FEE

Boundary Survey and Platting - Surveying services are invoiced using an hourly rate schedule. We try within reason to estimate the hours required to perform the services requested to arrive at a cost estimate. The cost estimate to perform a boundary and partition survey, as explained above, is estimated at \$11,500 $\pm 15\%$ (No tax, the City of Brenham is tax exempt). Includes <u>estimated</u> platting and associated fees and a current Title Report. The actual cost of the fees and Title Report could vary and will be invoiced at actual cost.




AGREEMENT FOR PROFESSIONAL LAND SURVEYING SERVICES

- 1. <u>Services Performed By Surveyor:</u> Surveyor agrees to perform the following services: Boundary survey and platting of a portion of the residue of Reserve "E" called 21.170 acres, Brenham Business Center Subdivision, Phase I, adjoining James Nutt Boulevard and Handley Street, situated in the Hiram Lee Survey, A-76 and the Isaac Lee Survey, A-77, City of Brenham, Washington County, Texas. (See attached proposal for scope of services).
- 2. <u>Compensation by Client:</u> Client agrees to compensate Surveyor for said services as follows: Charges to be based on actual time (hours) incurred, using an hourly rate schedule (see attached rate schedule). The estimated cost for the surveying services is \$11,500 ±15% (No tax, the City of Brenham is tax exempt). Includes estimated platting and associated fees and a current Title Report. The actual cost of the fees and Title Report could vary and will be invoiced at actual cost.
- 3. **Property:** The property upon which the services herein described are to be performed is located off of James Nutt Boulevard and Handley Street.
- **Authorization of Owner:** As owner or agent for the owner of the property, Client hereby authorizes Surveyor to enter upon the property for the purpose of conducting Surveyor's work thereon. If Client is not the owner of the property, Client agrees to obtain such authorization from the owner and provide same in writing to Surveyor.
- Surveyor monthly and shall be due and payable by Client at the time of billing at the address of Surveyor listed below. Any unpaid balance due after the expiration of 30 days from the date of the invoice will be subject to legal and allowable carrying charges. Further, any expenses incurred by surveyor to secure past due invoices, including but not limited to attorney's fees, filing fees, court cost, etc. will be at the expense of the client.
