4. Discuss and Consider Approval of Incentive Grant Fund Reimbursement of \$7,000.00 to Moser Community Media for Work on 101 E. Main.

Jennifer Eckermann reminded that the discussion of this project has been ongoing for several months and now that the project is completed, the Board is prepared to complete the process to reimburse Moser Community Media.

5. Discuss and Consider Approval of Economic Impact and Innovation Grant for \$15,000 for Commercial Hood Vent with Fire Suppression System for Catherine's Victorian Tea Room at 302 S. St. Charles.

Eckermann began by reminding the group that BCDC funds are a "use it or loose it" fund which will no longer be available after September 30. Eckermann says that by paying this item and item #6, this would utilize the BCDC funds for both projects before the end of September.

Jim Moser, on behalf of the Economic Vitality Committee, recommends to award both the \$15,000 to Catherine's Tea Room and \$15,000 to the 4 Star Concert Hall. Moser continued by stating that the Economic Impact and Innovation Grant's intention is to help business that are bringing unique and new entities to Downtown Brenham and the Economic Vitality Committee feels that both are committed to the spirit of the grant.

Connie Wilder expressed concern that this business is not unique to Brenham; that truly Catherine's Victorian Tea Room will be another lunch venue with similar menu items as many other Downtown restaurants.

A motion was made by Tom Whitehead and seconded by Jim Moser to approve the Economic Impact and Innovation Grant for \$15,000 for commercial hood vent with fire suppression system for Catherine's Victorian Tea Room at 302 S. St. Charles.

6. Discuss and Consider Approval of Economic Impact and Innovation Grant for \$15,000 for Fire Suppression at 4 Star Concert Hall, LLC at 209 S. Market Street.

Eckermann reminded the group that part of the purpose of the Economic Impact and Innovation Grant is to assist businesses in successfully meeting code compliance guidelines. The 4 Star Concert Hall stated in their grant request application that the project budget to complete a fire suppression system is \$31,884.00 and they are requesting \$15,000.00.
