3. Presentation and Discussion Relating to the Review of the Action Plan in the City of Brenham Parks, Recreation and Open Spaces Master Plan for 2015 – 2025

Community Services Director Wende Ragonis explained that in 2014, the Parks Board and Staff, with the support of the Brenham Community Development Corporation, created a ten-year Master Plan with the intent to review it every 12-18 months to ensure goals and objectives are met and to make any revisions as needed. Ragonis stated that the Board and Staff reviewed the Action Plan of the City of Brenham Parks, Recreation and Open Spaces Master Plan (Master Plan) around this time last year at when we met at Blue Bell Aquatic Center.

Community Services Specialist Crystal Locke explained that the packet information contained three action areas from the Master Plan – Parks and Recreation Park Development, Parks and Recreation Facilities, Parks and Recreation Trails. Locke provided an overview of each of the action areas.

Curtis Martin, Kenny Troup 74 Eagle Scout Leader, inquired about bike and walking trail enhancement in Jackson Street Park. Dane Rau explained that this is on staff's seven-year plan to expand some of the current trails in the City's parks and revise the park's ordinances to allow for bike on the trails. Biking and walking trails are included in the future Brenham Family Master Plan.

# 4. Discuss and Possibly Act Upon the Approval of the Minutes from the February 28, 2018 Meeting

### 5. Presentation and Discussion Relating to Blinn College's Use of Hohlt Park for Soccer

Public Works Director Dane Rau presented this item. Rau explained that the Blinn College Board recently approved Men's and Women's Soccer for 2018. As of this meeting, Blinn College does not have a soccer coach. Blinn College staff met with City Staff about using Hohlt Park as a permanent home for the Blinn Soccer Program. A Memorandum of Understanding (MOU) would be utilized for the use of Rankin Field and a practice field, either field #2 or field #4. Rau stated that details for the program under review, however, the main season is in the fall with approximately 18 games on the schedule with 8-9 games will be home games. Practice would most likely be between 1pm to 5pm weekdays. The schedule would be from August to November. Rau explained that there has not been a lot of recent activity on Rankin Field and this would be a good opportunity to use Rankin Field as well as the other fields.

Rau explained that the MOU still needs to be drafted; however, it will include reimbursement to the City for Blinn's usage and maintenance costs for the fields.

The Parks Board approved the usage of Hohlt Park's fields for Blinn College Men's and Women's Soccer program.
