Re: Presentation and Discussion Related to the Use of Alcohol and Tobacco in City of

Brenham Parks

Over the last few years we have had questions arise about the use of tobacco products and alcohol in City Parks. This is a very touchy subject and can be addressed in many ways. Currently we have no restrictions on either the consumption of alcohol or the use of tobacco products on City Park property. We will be soon update our park ordinances and these two are the most controversial. We are not suggesting that these be changed we are just wanting to see how the Parks Board recommends moving forward with both of these topics.

If you choose to address these two topics, city staff has supplied you with numerous other city's ordinances for review. These ordinances vary from strictly prohibiting the use of tobacco products and consumption of alcohol on park property to being specific to where and when they are allowed. Over the years, we have not had many issues but we have fielded calls from citizens who have found it disturbing when visiting playgrounds and play areas to have smoking or the consumption of alcohol so close to kid's play areas. Right now we do not have a mechanism to prevent this other than banning glass containers in our Parks.

We have asked Todd Ashorn from the Brenham PD to join us at the meeting so that board members can ask questions related to issues in the past, perspective from Brenham PD, and enforcement. We all understand that these parks are used for a time of gathering whether for birthday parties, family reunions, or community events. On these occasions many times facilities within the parks are rented to celebrate and enjoy these occasions. We are all okay with these and want our park visitors to enjoy themselves and the occasion. What we need to consider is the respect for others when they are in our Parks and enjoying recreation time with their young kids. This is where we have received most complaints regarding the use of tobacco products specifically smoking and consumption of alcohol.

We ask for your input on these topics and will bring back your recommendation at the next board meeting along with other ordinance additions that are not so controversial.

Alcohol

Current Ordinance: Sec. 19-11. – Glass containers prohibited.

College Station

13-H Glass containers – It shall be unlawful for any person to possess glass beverage containers in any portion of a park or recreation area.

Bryan

Sec. 86-60: Glass beverage containers prohibited.

- A) The following definitions shall apply to the provisions of this section: Exceptions and exclusions, notwithstanding any other provisions of this section, shall mean that nothing in this section shall prohibit the possession of the following glass containers in park and recreation areas:
 - 1) Glass-lined vacuum bottles and glass-lined picnic beverage coolers; and
 - 2) Baby bottles or baby food jars containing products for consumption by a baby.

Glass beverage containers shall mean any glass receptacle which meets one or more of the following criteria:

- 1) Has at some point in time contained a beverage;
- 2) Currently contains a beverage;
- 3) Was created for the purpose of containing a beverage.

Galveston

Sec. 26-4. Alcoholic beverages.

It shall be unlawful for any person to consumer, carry or bring any alcoholic beverage in or upon any park or playground in the city without a written permit from the director of parks and recreation.

Sec. 26-11. Glass containers prohibited.

It shall be unlawful for any person to use or possess any glass container in or upon any public park situated within the corporate limits of the city.

Bastrop

- H) Alcoholic beverages. Possession, use or consumption of any alcoholic beverage, as defined in the Texas Alcoholic Beverage Code, now or as amended, within the area of the city parks shall conform with the laws of the city and the state. For specific regulations related to the sale, possession and consumption of alcoholic beverages in Bastrop's public parks please refer to City Code, article 8.02, section 8.02.002, which provides additional information on this topic in addition to this general requirement to conform to all laws and codes.
- (j) Glass containers. It shall be considered a misdemeanor offense for anyone to exhibit, use, carry, or dispose of glass beverage containers in all city parks which have adjacent areas by rivers, lakes, and streams within the city limits.

Pasadena

Sec. 24-7.1. – Glass receptacles – Prohibited.

It shall be unlawful for any person to bring into or upon any park or playground, or into or upon any other public ground under the jurisdiction and control of the department of parks and recreation, or have in his or her possession or under his or her care, custody and control while therein or thereupon, any glass receptacle, including, but not limited to, glass bottles, glass jars, drinking glasses and glass containers of any kind.

Sec. 24-7.2. – Same – Penalty for violation of section 24-7.1.

Any person who shall violate the provisions of section 24-7.1 above shall be guilty of a misdemeanor and shall be guilty of a misdemeanor and shall be fined not less than one hundred dollars (\$100.00) or more than five hundred dollars (\$500.00).

Sec. 24-8. – Alcoholic beverages prohibited in certain public recreational facilities; penalty.

- (a) No alcoholic beverages shall be permitted to be sold, possessed, carried onto or consumed on the premises of public parks and recreational facilities or public golf courses with the exception of the Pasadena Fairgrounds and Pasadena Municipal Golf Course. It is the specific intent of this section that the term "premises" includes any and all parking facilities adjacent to said recreational facilities that are owned, operated or controlled by the City of Pasadena.
- (b) Any person violating any provision hereof shall be deemed guilty of a misdemeanor and upon conviction in a court of competent jurisdiction shall be fined not less than one hundred dollars (\$100.00) nor more than five hundred dollars (\$500.00).

Pearland

Sec. 21 ½-29. Possession or consumption of alcoholic beverages prohibited at certain athletic events.

It shall be unlawful for any person to possess or consume alcoholic beverages in a park while attending any athletic event or practice session specifically organized for participants under the age of eighteen (18).

Sec. 21 ½-30. Possession or consumption of alcoholic beverages at public swimming pools prohibited.

It shall be unlawful for any person to possess or consume alcoholic beverages within the fenced or enclosed boundaries of all swimming pools owned and/or operated by the city.

Sec. 21 ½-31. Glass bottles, containers prohibited.

- (a) It shall be unlawful for any person to possess any glass container in any city-owned or city-controlled park.
- (b) For purposes of this section, "glass container" shall mean any receptacle, made wholly or partially of glass, which is designed for the storage or consumption of any food or beverage.

San Marcos

Sec. 58.033. – Public display or consumption of alcoholic beverages in city parks.

- (a) It is unlawful for any person to publicly consume or display alcoholic beverages within a city park. No person shall be issued a citation or arrested for an offense under this section unless the person that first been issued a verbal warning and given an opportunity to comply with this section.
- (b) It is a defense to prosecution that the alcohol was consumer or displayed within a special event contract designated area of a rented pavilion, park, facility, or picnic tables, and the person is a part of the group that rented the area.

Sec. 58.034. – Glass beverage containers prohibited.

(a) It is unlawful for any person to possess any glass beverage container in any city park.

New Braunfels

Sec. 86-8 – Glass containers prohibited in parks areas and on rivers, lakes and streams.

(a) It shall be considered a misdemeanor offense for anyone exhibiting, using, carrying or disposing of glass beverage containers in all city parks which have areas adjacent to the rivers, lakes and streams within the city limits, and at all city sports facilities, including, but not limited to, the following: ...

Sec. 86-10. – Prohibition of alcoholic beverages in city parks and city-owned property.

- (a) It shall be unlawful for anyone to consume intoxicating liquor or any alcoholic beverage, or possess an open container of intoxicating liquor or alcoholic beverage within the boundaries of the following public parks or city-owned property within the city limits: ...
- (b) It shall be unlawful for anyone to consume intoxicating liquor or any alcoholic beverage, or possess an open container of intoxicating liquor or alcoholic beverage in all designated parking areas or within 25 feet, either side of any roadway, within the boundaries of the following public parks or city-owned property within the city limits:...
- (c) The provisions of subsection (a) shall not apply to a city-permitted function where the consumption and possession of intoxicating liquors or alcoholic beverages are permitted as part of the activity.

Austin

8-3-1 – Alcoholic Beverages Prohibited.

Except as provided in Section 8-3-5 (Temporary Sales of Beverages and Food), a person may not knowingly sell, possess, or consume an alcoholic beverage in:

- (1) The fenced, enclosed area surrounding a swimming pool in a park, or within 100 feet of an unenclosed swimming pool in a park;
- (2) A recreation facility or adjacent outdoor area that is part of the recreation facility including a field, playground, parking lot, play slab, or play-scape;
- (3) All or part of a park or playground designated by the director as being an area in which the sale, possession, or consumption of alcohol is prohibited;
- (4) The playing area or dugout of an athletic field;
- (5) A school district/playground area; or
- (6) A nature preserve
- 8-3-6 Glass Containers Prohibited in Certain Areas.
 - A) A person may not knowingly or intentionally possess a glass container in the fenced, enclosed area surrounding a swimming pool in a park, or within 100 feet of an unenclosed swimming pool in a park.
 - B) Except as provided in Section 8-3-8 (Exception to Prohibition on Glass Container) a person may not knowingly or intentionally possess a glass container in:
 - (1) A recreation facility or adjacent outdoor area that is part of the recreation facility including a field, playground, parking lot, play slab, or play-scape;
 - (2) All or part of a park, playground, or nature preserve designated by the director as being an area in which a glass container is prohibited;
 - (3) The playing area or dugout area of an athletic field;
 - (4) A school district/playground area; or
 - (5) A lake, river, steam, shoreline, or beach.
 - C) The director may adopt rules restricting possession of a glass container by a person in a park, public recreation area, or nature preserve located outside of the city limits that is under the administrative control of the department.

Round Rock

Sec. 4-5. – Unlawful to drink or possess intoxicating liquors within certain areas.

- (a) Ball fields. It shall be unlawful for any person, firm or corporation to carry, possess, or drink any alcoholic or intoxicating beverage in any city-owned or –operated baseball or softball field while a person or persons of non-drinking age are participating in organized league play.
- (b) Swimming pool areas. Except as provided herein, it shall be unlawful for any person, firm, or corporation to carry, possess, or drink any alcoholic or intoxicating beverage in any city-owned and –operated swimming pool area. The foregoing prohibition shall not apply to any swimming pool owned by the city, but operated or managed by a third party under contract with the city.
- (c) Park areas. Permits. It shall be unlawful for any person, firm or corporation to sell any alcoholic or intoxicating beverage in any city-owned or –operated park without first obtaining a permit therefore from the chief of police. The decision of the chief of police to grant or deny any such permit shall be appealable to the city council.

Grapevine

Sec. 16-5. – Alcoholic beverages in parks

- (a) Except as provided by subsection (b), it shall be unlawful for any person to possess or consume any alcoholic beverage in a public park of the city.
- (b) Consumption of alcoholic beverages is permitted at Grapevine Lake and the reservoir area.

Fort Worth

24-17 Alcoholic Beverages – Prohibited in Ball Fields

- (a) It shall be unlawful for any person to knowingly or willfully sell, possess with the intent to sell or consume any alcoholic beverage in the following areas:
 - (1) Within the fenced enclosed areas surrounding any swimming pool, wading pool or spray pool within any park of the city;
 - (2) Within any recreation or community center or the parking lots of any recreation or community center; or
 - (3) Within any areas of a wildlife preserve.
- (b) It shall be unlawful for any person to knowingly or willfully sell, possess with the intent to sell or consume any alcoholic beverage within any area of a park, playground or athletic field that has been designated by the park and recreation director as being an area in which alcohol consumption, sale or possession is prohibited and has been so designated by signs indicating such prohibition. A sign or signs shall be conspicuously posted prohibiting the possession of alcohol.

Texas Parks & Wildlife State Park Rules

Public display or consumption of alcohol is prohibited. All outdoor areas within the park are public.

Tobacco & Smoking

Current Ordinance: No current ordinance pertaining to use of tobacco.

Galveston

Sec. 26-14. Smoking in public parks.

- a) It shall be unlawful for any person to smoke in any city park. As used in this section, "smoke or smoking" shall include the carrying or holding of a lighted pipe, cigar or cigarette of any kind, or any other lighted smoking equipment or device that contains a burning tobacco product, and the lighting of, emitting or exhaling the smoke of a pipe, cigar or cigarette or other tobacco product of any kind.
- b) The violation of any provision of this section shall be unlawful and a misdemeanor offense punishable by a fine not exceeding two thousand dollars (\$2,000.00). Each day any violation of this section occurs shall constitute a separate offense. Each premises on which a violation of this section occurs shall constitute a separate offense.

Pearland

Sec. 21 1/2-25. Smoking.

Smoking in or upon any park property shall be governed by chapter 20 of this Code of Ordinances.

Sec. 20-9. - Smoking in public places. (Summarized)

- (1) A person commits an offense if the person smokes in an enclosed public place, as well as those outdoor areas designated in subsections (d) and (e), including, but not limited to, the following places:
- (2) A person commits an offense if the person smokes in an enclosed area of a workplace without exception. This includes common work areas, auditoriums, classrooms, conference and meeting rooms, private offices, elevators, hallways, medical facilities, cafeterias, employee lounges, stairs, restrooms, vehicles, and all other enclosed facilities.
- (3) A person commits an offense if the person smokes within twenty-five (25) feet from an entrance, operable window, or ventilation system of an enclosed area in which smoking is prohibited.
- (4) The owner or operator of a public place commits an offense if the person fails to take necessary steps to prevent or stop another person from smoking in an enclosed area in a public place.

San Marcos

Sec. 58.035. – Smoking and chewing tobacco.

- (a) It is unlawful for any person to smoke or chew tobacco in the play-scape area of Children's Park.
- (b) It is unlawful for any person to smoke or chew tobacco on or around any play area or athletic field area designated with borders, fences or other designations indicating play or program areas.

New Braunfels

Sec. 86-4. – Additional rules and regulations for control of parks and recreation areas and facilities.

(j) smoking and the use of tobacco products is hereby prohibited on or within 50 of any outdoor city-owned youth athletic fields, skate park, playgrounds, or playground equipment located within the city limits of the city.

Round Rock

Sec. 14-242. – Prohibition.

- (a) Except as provided in subsection 14-243 (a), smoking and/or vaping is unlawful inside of and outside within five feet of any entrance or open window of the following places:
 - (1) Common areas
 - (2) Elevators
 - (3) Places of employment
 - (4) Public conveyances
 - (5) Public places
 - (6) Public restrooms
 - (7) Taxicabs
 - (8) Service lines
 - (9) Sports arenas
- (b) No smoke and no vaping shall be designated by signs posted in conspicuous locations located at any entrance to and within all public places and places of employment. Such signs shall be visible to the public and clearly recite the phrase "No Smoking, No Vaping" and/or use the international no-smoking and no vaping symbols.

Grapevine

Sec. 16-18. – Tobacco and e-cigarette free parks and park facilities.

- (a) It shall be unlawful for any person to smoke e-cigarettes or tobacco or chew or dip tobacco or snuff at any parks or park facility owned or leased by the city that has been posted: "This park/park facility is tobacco and e-cigarette free."
- (b) The council shall designate any city owned or leased park or park facility as tobacco and ecigarette free and upon such designation, the city manager or the city manager's designee is authorized to post signs giving notice that such action is prohibited in such park or park facility.

Texas Parks & Wildlife State Park Rules

- (h) Fires, Firewood, Smoking and Fireworks. Portable gas-fueled camp stoves may be used in designated campsites or picnic areas; however, it is an offense for any person to:
- (1) light, build, or maintain a fire within a state park except in a facility or device provided, maintained, or designated for such purposes or to smoke or build fires when an extreme fire hazard has been posted by the department or a burn ban has been instituted by local government ordinance;
- (2) gather firewood except when authorized by permit;
- (3) leave a fire unattended; or
- (4) possess within a state park any fireworks, explosives, or similar devices capable of explosion, or to discharge, set off, or cause to be discharged in or into a state park any such device or substance, except with written authorization from the director.

2. Citizens/Visitor Comments

There were no citizen comments.

WORK SESSION

3. Discussion and Presentation Relating to the Participation in the Texas Parks and Wildlife Local Park Grant Program for the Brenham Family Park

Director of Public Works Dane Rau and Community Services Specialist Crystal Locke presented this item. Locke explained that Texas Parks and Wildlife Department (TPWD) offers a local grants program. Staff recommended the City apply for a Non-Urban Outdoor Recreation Grant to begin Phase I(a) of Brenham Family Park. This program provides fifty percent matching grants on a reimbursement basis. The grant ceiling is \$500,000 and the deadline is October 1, 2018.

Rau continued and described what Phase I(a) would include – additional trails for walking and biking, security lighting, wildflower viewing areas, restrooms, a trail bridge, road extension, parking and signage. Rau said that Brenham Community Development Corporation (BCDC) has been really good about committing money for this park, which is where our match for this grant will come from.

5. Discuss and Possibly Act Upon the Recommendation to Participate in the Texas Parks and Wildlife Local Parks Grant Program for the Brenham Family Park

Chairperson Betts asked for any further discussion on this item. Rau encouraged members of the Park and Recreation Advisory Board to attend next week's council meeting in support of this recommendation.

A motion was made by Delbert Boeker and seconded by Paula Buls to proceed with the application to participate in the Texas Parks and Wildlife Local Grants Program for the Brenham Family Park.

6. Discuss and Possibly Act Upon a Public Art Project Placed on the Grounds Near Nancy Carol Roberts Memorial Library in Fireman's Park.

Evonne Sturm, acting Community Art Project Coordinator for the Brenham Fine Arts League (BFAL) introduced herself and the other Fine Arts League members present - Ruth Wilson, Gail Breeland, and Alberta Kaufman. Sturm mentioned that within their membership they have an amazing collection of world renowned artists, sculptors, and photographers. Their biggest Community Art Project to date is displayed at the Brenham Clinic – murals in both pediatric waiting rooms.

Ruth Wilson introduced her creation, Dibley Seymour, and explained that BFAL would like to place a bronze statue of Dibley in the park (Fireman's Park) next to the Library. Wilson explained that to produce Dibley as a five foot bronze statue would take approximately six months for completion and that ideally, BFAL would like to position Dibley in the Serenity Garden where it will be totally accessible to children and people of all ages.

Strum explained that BFAL is looking for support for the placement of Dibley, financial backing for this project would happen through private donations.

Chairperson Betts opened the floor for questions. Boeker asked how big the footprint of the statue is. Sturm replied, two and a half to three feet wide. She also mentioned it would potentially be a year out before this project comes to pass. Ogle stated that the Library Advisory Board was supportive of this project, but wanted this concept to come before the Parks and Recreation Advisory Board since the Library is located in Fireman's Park.

Rau stated that staff will work with them to find a great home for Dibley. It may not be directly in the serenity garden, but it will be close. Members of the Brenham Fine Arts League requested for it to be visible.

A motion was made by Paula Buls and seconded by Delbert Boeker to approve the statue location in the park, near the Library at a location to be worked out with City staff.

7. Parks and Recreation Update

> Administration

Director of Public Works Dane Rau provided the following update:

- o Fireman's Park Restroom update completion is scheduled for November, Thielemann Construction is in charge of this project
- O Henderson Park Phase I Improvements bid will go out in two weeks, staff will select a contractor and get started. Phase I includes sidewalk improvements, ADA parking, ADA accessibility to pavilion and concession area, and BBQ pit area. Phase II was approved by BCDC and will include improvements to the baseball field. The new playground equipment near the kitchen has been installed and basketball improvements are complete
- Blue Bell Aquatic Center Leisure Pool repairs currently working with an engineer, bid specs to come out by the end of the week, staff will select a vendor, and begin repairs after the annual KidFish event at the end of October

> Recreation

Community Services Specialist Crystal Locke provided the following update:

- o Movies in the Park an average of 322 residents and visitors attended each showing.
- o Hot Nights, Cool Tunes thousands of residents and visitors enjoyed this concert series in July.
- Roll and Read first time program offering to promote early literacy and physical well-being. Partnered with the Nancy Carol Roberts Memorial Library and Boys & Girls Club of Washington County for a half-mile story time trail at Fireman's Park. Sixty-two preschool participants plus family attended the event.
- Future programs and events: Little Diggers Volleyball for girls 3rd-6th grades, 50 participants registered, Walk with a Doc on September 29, 2nd Annual Boo Bash scheduled for October 31, and mentioned Pop-up Play Days
- o Staff will begin planning and updating images and materials for the 2019 annual Parks and Recreation Guide.

- Visits decrease in number of summer visits due to postponed leisure pool opening and weather, leisure pool closed for 14 days – scheduled to open on June 23 and were able to open seven days prior, an additional seven days were added to the end of the summer calendar
- o Staffing hiring for Fall lifeguard staff from 7 a.m. to 1:30 p.m. Monday-Friday
- Usage Brenham High School has 25 swimmers and Brenham Junior High has 29 swimmers. Home Swim Meets begin in October, excited to add inflatables to drive traffic during the fall and spring, and aerobic classes continue to grow.
- o Programs, Publicity, and Special Events Swim Lessons this Fall, BBAC will participate in the Fair parade, and KidFish is October 27

Parks Superintendent Casey Redman provided the following update:

- o Routine Maintenance mowing, weed eating, checking water rotors, and fixing leaks
- Deadwood Removal at Hohlt Park focused on walking trail, trimmed deadwood within 10 feet of trail
- o Fall youth leagues beginning preparing and painting fields to host two local youth football leagues and one local youth soccer league
- o Blinn soccer season is underway and running smoothly
- o Rankin Scoreboard order placed and should be in by the end of the month
- o Airplane project to be complete by Veteran's Day dirt has been moved and pad installed at Henderson Park, scheduled to move plane on Saturday, September 29
- All Sports Building parking lot construction underway paperwork is complete, setting stakes, new parking lot to be completed in a few weeks
- o Stephen Gerhard will bring tournament re-cap at the end of the year

Chairperson Bill Betts asked staff for the following updates:

- o Progress with park users and shared facility responsibilities
- Vacant Parks and Recreation Advisory Board position and the process moving forward for filling the position
- Look at scheduling a meeting this fall in one of our a neighborhood parks possibly coincide with Pop-up Play Days

City Engineer and Director of Development Services Lori Lakatos introduced herself and Assistant Director of Development Services Stephanie Doland. Lakatos mentioned that the City is moving forward with the Comprehensive Plan. Their recommendation is for one member from each board to serve on the Comprehensive Plan Advisory Committee (CPAC) to assist with guidance on how this plan moves forward. They are seeking a primary and alternate Parks and Recreation Advisory Board member. The Comprehensive Plan will address priorities and develop a detailed work plan for the city that helps the community protect the quality of life while developing a long-term sustainable city. Paula Buls will be the primary member of CPAC and Ginger Bosse will be the alternate member.

Staff last presented rates for Parks, Recreation, and Aquatic facilities and programs to the Parks and Recreation Advisory Board at the August 10, 2016 board meeting. At that time Blue Bell Aquatic Center (BBAC) rates were discussed, specifically family passes and aerobic classes. Staff's recommendations was to include an "add on" option to family passes and offer a monthly fee for water aerobics classes. The board agreed with staff's recommendations and there were no other changes to facility and field rentals at that time.

Staff has been reviewing current facility and field rental rates and are recommending rates be increased. Paragraphs below give a brief summary as to when these items were last presented and action taken by the board.

Facility rental fees were brought before the board on December 10, 2014. Staff recommended a consistent fee schedule for all air conditioned/heated park facility rentals. The option to rent Fireman's Kitchen without AC/heat was no longer a possibility. The rate to rent Fireman's Kitchen is \$65 per half-day and \$90 per full day. The cost to rent Henderson Park Kitchen increased from \$25 per half-day and \$40 per full day to \$45 per half-day and \$60 per full day due to AC/Heat being installed. This increase was consistent with Jackson Street Park Kitchen and Fireman's Park Rock Room. Deposit amount for all park rental facilities were set at \$100, instead of \$50. All other facility published rates remained unchanged.

Field rates were last brought before the Board on October 10, 2012. Staff reviewed current rates and provided a handout which outlined rental rates from surrounding cities and cities with similar facilities. The Board chose not to change the rates at that time. Current rates were set by the Board April 9, 2008.

Included in this memo are two attachments. (1) A comparison of current and proposed facility and field rental rates and (2) our proposed 2019 Parks and Recreation Fee Schedule including the proposed facility and field rates. Recommendation from Parks and Recreation Advisory Board will be taken before City Council in January for approval before publishing.
