PARB Board Members

Staff was awarded \$300,000 for the addition of a splash pad to be placed in a city park during the FY20 Brenham Community Development Corporation (BCDC) funding meeting. Staff is looking to construct a 2,000+ sq. ft. splash pad with a total area of approximately 2,800 sq. ft. which includes a 5' buffer area.

The following two parks, Fireman's and Henderson, were identified and discussed at the previous Board meeting on August 14.

Since then, staff created and posted an online survey for community input and would like to visit with the Board again to get additional input on the preferred choice pertaining to Fireman's Park and Henderson Park.

Fireman's Park – open space adjacent to parking lot and behind small pavilion

Advantages

Disadvantages

- Existing supporting amenities: pavilion for shade, seating, and parking next to site
- ADA sidewalk from parking lot to pavilion will allow for easy extension to route to site
- Newly constructed restrooms
- 2" water line along the creek channel south of location if pass through system is preferred
- Site is flat no trees or playgrounds located in the direct area

- Sewer has not been identified
- Parking

Henderson Park - open space area between N. Valley Street and bridge

Advantages

- Openness of the area
- Visible from N. Market and N. Park
- Underutilized parking off N. Park
- No playgrounds or trees in the direct area which may cause additional maintenance
- Water and sanitary sewer are close that will allow for easy extension

Disadvantages

- Natural slope of property will require additional dirt work
- Restrooms are located approximately 200 yards from the site
- Parking is approximately 330 feet from main parking lot
- Support amenities will need to be added - shade, seating

Staff would like to settle in on a site and get feedback on the comments that were submitted through the survey. Ultimately we want to make an immediate impact and have a splash pad that all will enjoy.

PARB Board Members

Over the last 6-8 weeks, staff along with Jones-Carter and Wes Hall (Kruse family representative) have been in discussion regarding the design and location of the lake structure on the future park development. It was brought to our attention several months ago that the vision of having an on-channel lake/detention pond was not going to be allowed by the Corps of Engineers and was denied. With knowing that and also staying with the wishes of the Kruse family we have looked at options to have a pond/lake or multiple ponds/lakes on the future parkland that will also handle detention from the private tracts around the site. This does not have to occur but since the on-channel pond is no longer a consideration we have to look at other options which include a mixture of multiple ponds/lakes serving as detention ranging from 4-6 ponds with sizes anywhere from .5 acre to 7 acres. (See attached maps). We are working through this and also reconfiguring the layout of the park to keep the amenities as discussed in the community group meetings as well as the initial Park Master Plan that was created in 2017.

Before we spend additional money on designing new layouts we want to get the Boards opinion on these preliminary designs conducted by Jones-Carter. With the sanitary sewer line going in ahead of the park development along the creek channel we will have to design around that. This will serve the Baker Katz development and be served by a lift station on the park property.

Staff has many options before we have to decide on a permanent design related to this park. We will work diligently with the Kruse family on the intent of the park and its amenities and also take into consideration the future operations and maintenance that a design will occur. We may have to look at other options of having an off-channel lake structure solely for recreational use and not take on detention from private development.

We will strive to meet the needs of the community and Parks Board and also work towards our goals of providing different amenities that other parks do not have.

We just want to share with you the most recent developments and some options that have come our way. Staff plans to apply for a Texas Parks and Wildlife Department (TPWD) grant for Phase 1 (a) of this park and plan to continue in talks of a permanent design that will satisfy the majority.






BRENHAM FAMILY PARK PLAN

WASHINGTON COUNTY, TEXAS




VICINITY MAP Scale: 1 inch equals 10 miles

The staff recently met with Michelle Rigsby, Camp Gladiator Trainer, who is offering Camp Gladiator (CG) workouts in the parks.

CG is a four-week outdoor group fitness program for all fitness levels. Every workout is different, incorporating full-body exercises led by Certified Personal Trainers. The campers get unlimited workouts at all the 4,000+ locations nationwide to fit their lifestyle.

Brenham Camp Gladiator - Free Fall Schedule (November 18-December 14)

Monday/Wednesday/Friday – 5am and 6:15am at Hohlt Park Field 4

Monday/Wednesday/Friday – noon at Jackson Street Park

CG classes happen rain or shine. Rigsby has also requested the use of the pavilion off Lounge Road at Hohlt Park in case of inclement weather and the use of Jackson Street Park kitchen/open air pavilion for back-up.

Beginning January 2020 there will be a fee to participate.

CG Membership Structure (based on website)

Try a week of unlimited workouts for FREE at any of the 4,000+ locations

Four Week Camp - \$189 for a single camp purchase, no monthly commitment

BOLD 6+ - \$85/month (6-month minimum)

BOLD 12+ - \$75/month (12-month minimum)

BOLD 24+ - \$65/month (24-month minimum)

Staff feels this style of program is like a bootcamp but is offered on a more consistent basis throughout the entire year versus a 6-8-week program. Staff is looking to the Board for direction on how to move forward with this request (i.e. insurance requirements, fees, etc.).



City of Brenham Parks & Recreation Advisory Board Minutes

A regular meeting of the Parks and Recreation Advisory Board was held on Wednesday, August 14, 2019, beginning at 12:00 p.m. at Brenham City Hall, Conference Room 2-A, 200 W. Vulcan Street Brenham, Texas.

1. Call Meeting to Order

2. Citizens/Visitor Comments

Citizen DeeAnna Marek said the splash pad would be a great asset to Brenham. Chairperson Betts thanked Marek for attending and mentioned the splash pad would be discussed as an item on the agenda.

WORK SESSION

3. Presentation and Discussion Regarding the Addition of a Splash Pad in a City Park

Director of Public Works Dane Rau presented this item. Rau reminded the Board that the Brenham Community Development Corporation (BCDC) set aside \$300,000 in FY20 to place a splash pad in a city park. Rau mentioned staff is looking at an approximately 2,000 sq. ft. design and has identified two potential sites at Fireman's Park and Henderson Park to discuss with the Board.

Option 1 is at Fireman's Park, the open space adjacent to the parking lot, behind the small pavilion. Rau noted that existing support amenities make this option attractive, so the bulk of funding can be used for the splash pad. This location offers a 32-space parking lot, a pavilion for shade, seating, ADA sidewalks, and new restrooms. However, Rau mentioned that Fireman's Park is a popular park for parties and the rental facilities are at capacity on weekends.

Option 2 is at Henderson Park, the open space between the bridge and N. Valley Street. Rau mentioned this location being a considerable option due to the openness of the area, underutilized parking located off N. Park Street with approximately 52-spaces, visibility from N. Market and N. Park Streets, and both water and sanitary sewer are in proximity and could easily be extended. Alternatively, Rau noted this location does not have the support amenities that option 1 (Fireman's Park) has. Restrooms and parking are further away and there is no shade structure or seating.

Examples of splash pads were presented to the Board, as well as short videos of each of the location options.

Board Members discussed splash pad locations in proximity to flood areas, water usage, future expansion, maintenance, and additional location options.

Board Member Fischer asked if City staff had talked to the staff at the Brenham State Supported Living Center (BSSLC) about the splash pad project and noted that BSSLC had plans to add a splash pad to their location years ago, but it did not happen.

Citizen Linda Thomas also inquired if this had been discussed with BSSLC.

Citizen Raileen Murray added that as a mom it makes sense to add the splash pad to Fireman's Park because it's close to all the play areas and convenient.

Rau mentioned staff would continue to discuss splash pad locations based on feedback from the board and citizen's comments.

4. Presentation and Discussion Regarding the National Fitness Campaign

Director of Public Works Dane Rau opened this discussion with a short video that explained the National Fitness Campaign (NFC). Rau informed the Board that NFC had contacted him with general information about adding a fitness court in Brenham and that NFC provides grant funding every year for eligible communities in the amount of \$30,000. Rau noted that staff would likely include this project for FY21 funding through the Brenham Community Development Corporation (BCDC) for the remaining costs. The total project cost would be approximately \$175,000. Rau stated that staff likes the concept of the fitness court and feels this amenity would benefit the community's health and wellness by providing free outdoor fitness.

Board Member Baker was very receptive and thought this was a great idea. Citizen Linda Thomas referenced a meeting at the Library she attended, For the City, where the needs of Washington County residents were presented and mentioned reaching out to this group for more information.

Board Member Boeker questioned if the court would be staffed. Rau noted that the court would not require additional staff and that the program offered freestyle workouts or guided routines using an app downloaded on an electronic device.

Citizen Raileen Murray commented how this amenity would fit nicely into the Brenham Family Park along with Yoga pads and bike trails and would draw people to the area.

The consensus of the Board was to proceed with the grant application.

5. Presentation and Discussion Regarding Updates to Chapter 19, Parks and Recreation, of the Code of Ordinances of the City of Brenham

Deputy City Secretary II Karen Stack presented a new draft that incorporated suggestions and input from Park Board members and the Brenham Police Department (PD). The following changes have been made since the June 26, 2019 meeting.

Sec. 19-1: Definition of camping has been amended to clarify that camping is overnight. This change was made in response to concerns from the Board that during tournaments there are individuals who make daytime use of campers and RVs at the parks. Also, the use of hammocks was added at the suggestion of PD.

Also, in Sec. 19-1 the definition of smoking has been updated to use the language developed by the Parks Board in conjunction with City Secretary Jeana Bellinger. The new language is designed to include vaping and electronic cigarettes.

Sec. 19-2, 19-6, and 19-7: New language has been added at the suggestion of PD, clarifying that when an individual has reserved an otherwise public facility for private use, it is closed to the general public.

Former Sec. 19-5 regarding firearms has been removed. This is based on input from the Board, and upon advice concerning enforceability issues.

Sec. 19-28 has been added, providing for an appeal process when a permit has been denied.

Stack noted that small grammatical changes have been made throughout the ordinance for clarity and consistency at the suggestion of the City Attorney's Office.

Stack also addressed concerns expressed by the Board regarding general behavior, indecency, inappropriate dress, and foul language. Stack provided copies of the Texas Penal Code Section 42.01 which generally prohibits this type of behavior in public. Stack noted that the state statutes addressed each of these things, staff did not feel the need for the provisions to be duplicated in the Ordinance.

Chairperson Betts questioned the appeal process to the City Manager if any person is dissatisfied with a decision of the City Manager or designee. Betts commented that he felt there should be more due process included. Stack commented that staff would discuss this further with the City Attorney's Office.

No other questions or comments were made in the work session.

- Completed annual report for the Skate Park grant through Texas Parks and Wildlife Department (TPWD)
- Begin coordinating 5-year update to the Parks System Master Plan
- Meet with TPWD Local Park Grants staff to discuss Brenham Family Park project and Nature Trail project.

Blue Bell Aquatic Center (BBAC)

Blue Bell Aquatic Center Superintendent Tammy Jaster provided the following updates:

- ▶ Visits current daily visits, passes, and revenues were presented to the Board
- Staffing summer staff hired, working on staff for fall; Tammy Jaster and Kelsey Toy attended Special Olympic Swim Team Training; Jordan LaBeth was hired as FT Maintenance Technician

- Modified fall hours begin August 14
- Rec Trac migration (upgrade to Parks and Rec software system) will take place September 8-15
- > A list of programs, publicity, and special events were presented

Citizen DeeAnna Marek asked staff if there had been discussion about adding a wave pool to the Blue Bell Aquatic Center to reach an older age demographic. Jaster responded that staff has discussed the addition of an outdoor competition pool and that the initial BBAC Phase II included a lazy river and a second slide.

Jaster also noted that the contract with Trade Winds Physical Therapy has been finalized and the Board and community will begin to see aquatic therapy classes offered at the BBAC in the next few weeks.

Parks Maintenance

Parks Superintendent Casey Redman provided the following updates:

- Aerating and top-dressing all fields
- Batting cage project at Linda Anderson Park is underway
- > Park signs are complete at Jerry Wilson and Hattie Mae Flowers parks
- > Fireman's Field backstop netting project is complete
- > Press box at Fireman's Field is under construction
- > Washington County Youth Soccer Association will start the fall season soon
- ▶ Hattie Mae Flowers Park basketball court light installation will begin soon

Tournament update:

- Parks hosted 7 multi-day tournaments and 1 single day tournament including 6 baseball and 2 softball events
- > 16 tournaments scheduled for the remainder of the year

Rau noted that the City and Blinn College have a field use agreement for the men's and women's soccer teams. Rankin Field at Hohlt Park would host home games and Blinn teams would practice on Field 2 at Hohlt Park. Blinn opted to pay an additional fee to practice at Hohlt Park instead of Jackson Street Park.

Per Chapter 19, Parks and Recreation, of the Code of Ordinances of the City of Brenham fees for all parks and recreation activities shall be set by resolution of the City Council. All such fees shall be posted, where applicable, and kept on file with the City Secretary.

The paragraph below gives a brief summary as to when these items were last presented, and action taken by the board.

At the December 12, 2018 Parks and Recreation Advisory Board (PARB) meeting, staff reviewed the current Parks and Recreation rate schedule with the Board and recommended increases for the facility and field rates. Proposed rates were recommended by the PARB and approved by Council in January 2019.

Below is an outline of recommended changes for 2020.

- Staff is presenting a slight increase in the addition of inflatables for the fall/spring competition pool parties
- Staff is looking to the Board for direction regarding Camp Gladiator and other like programs

Included in this memo is the 2020 Parks and Recreation Fee Schedule. Recommendation from the Parks and Recreation Advisory Board will be taken to City Council in December for approval before publishing rates.

The Community Outdoor Outreach Program (CO-OP) grant provides funding to local governments and non-profit organizations for programming that introduces under-served populations to environmental and conservation programs as well as TPWD mission oriented outdoor activities.

Staff recommends the City apply for the Community Outdoor Outreach Program grant in order to be able to offer Angler Education Week. The CO-OP grant is a reimbursement grant offered by TPWD. The BBAC would be asking TPWD for funds in the amount of \$14,495.36 to cover costs for basic supplies, refreshments, banners, promotional items, and activity supplies. (Budget request is outlined in the Angler Education Week Proposal).

For the last twelve years, the Blue Bell Aquatic Center hosts an annual KidFish event that we offer free to the community. Over the last few years, we have noticed that we are getting more kids that have little to no knowledge of how to fish. We do our best to help, but with so many people and a limited number of staff and volunteers, we are not able to give the kids the attention they need to learn. Through the CO-OP grant, the City will be able to offer these kids a chance to explore all there is to fishing sparking interest in the outdoor.

We are excited about this opportunity to receive funds to begin Angler Education Week. Our goal is to have the Angler Education Week October 19th – 25th leading straight into KidFish on October 24th.

We would like to ask parks board to consider allowing staff to move forward with this grant.

Texas Parks and Wildlife Department (TPWD) offers the Local Park Grant Program that consists of five individual programs that assist local units of government with the acquisition and/or development of public recreation areas and facilities throughout the State of Texas. All grant assisted sites must be dedicated as parkland in perpetuity, properly maintained and open to the public. Grants issued by TPWD should align with the goals and objectives in our Parks, Recreation, and Open Spaces Master Plan (Plan).

Staff recommends the City apply for the Local Parks Non-Urban Outdoor Recreation Grant. This program provides fifty (50) percent matching grants on a reimbursement basis to eligible applicants. The grant ceiling is \$750,000 and the application deadline is December 4. Project schedule guidelines: awards announced mid-May, site visit between June-July, and grant agreement issued in August.

Council adopted the 2015-2025 Parks, Recreation and Open Spaces Master Plan at their March 5, 2015 Council meeting. Staff then submitted the adopted Plan to Texas Parks and Wildlife Department (TPWD) for the agency to review and the City was notified on July 21, 2015 that our Plan met all standard requirements as identified by the agency and will qualify for points in their Local Park Grant Project Priority Scoring System.

The Brenham Family Park initial phase is included in our Plan. Phase I (a) contains of several outdoor recreation amenities Brenham residents cited in previous community meetings including a water feature suitable for fishing and passive recreation, additional trails appropriate for walking, jogging, and biking, along with security lighting, wildflower viewing areas, restrooms, a trail bridge, road extension, parking, and signage.

Jones Carter has provided us with preliminary construction cost estimates of \$1.7M for Phase I (a) in project costs and engineering services. Brenham Community Development Corporation (BCDC)

allocated \$500,000 to Brenham Family Park in their FY19-20 budget. In addition, BCDC has \$403,500 remaining from funds set aside in previous years for items included in Phase I (a). If we are awarded the TPWD grant, additional funding to complete Phase I (a) will be requested in the FY20-21 budget process.
