WORK SESSION

4. Discussion and Update Related to the Texas Parks and Wildlife Department (TPWD) Local Park Grant Program for Brenham Family Park and Recreational Trails Grant Program for the Nature Trail at Hohlt Park

Recreation Specialist Crystal Locke presented this item. Locke informed the Board that the National Park Service (NPS) opened a two-week window in December 2021 for the Land Water Conservation Fund (LWCF) application for the Brenham Family Park project. Locke noted the City worked with Texas Parks and Wildlife Department (TPWD) Grant Manager and submitted the application on December 17, 2021. Locke added the tentative project timeline:

- Pre-application review window December 17-March 11, 2022
- LWCF Formal Submittal March 11, 2022
- LWCF Grant Agreement Issued to TPWD June 1, 2022
- TPWD Grant Agreement issued and executed July 1, 2022

Locke explained that staff would continue to meet with Jones-Cater to work on the park design. Locke added that plans and specifications could be forwarded to TPWD before the grant agreement and pre-approved to start the bid phase and construction as soon as the agreement is signed.

Locke reported that the City had received the Recreational Grant Agreement from TPWD for the Crossover Nature Trail project at Hohlt Park. Locke added that the agreement would be presented at the February 17, 2022, Council meeting for approval.

5. Discussion and Update on Parks and Recreation Projects Funded in FY21-22

Director of Public Works Dane Rau presented this item. Rau updated the Board about various park and recreation projects and each project's status.

6. Presentation and Discussion Related to the 5-Year Capital Plans for FY23-28 for Parks, Recreation, and Aquatics

City staff presented and discussed the FY23-28 Capital Improvement Plan (CIP). Director of Public Works Dane Rau explained that the CIP is a planning and fiscal management tool used by the City's budget team. Rau added that the CIP includes a description of proposed capital improvements ranked by priority, an estimate of project costs, and potential financing sources. Rau said that the CIP is a working document that should be reviewed and updated annually to reflect changing community needs, priorities, and funding opportunities. Staff noted projects such as amenities at the Brenham Family Park, Blue Bell Aquatic Center, and the skate park.


