#### Parks Board Members

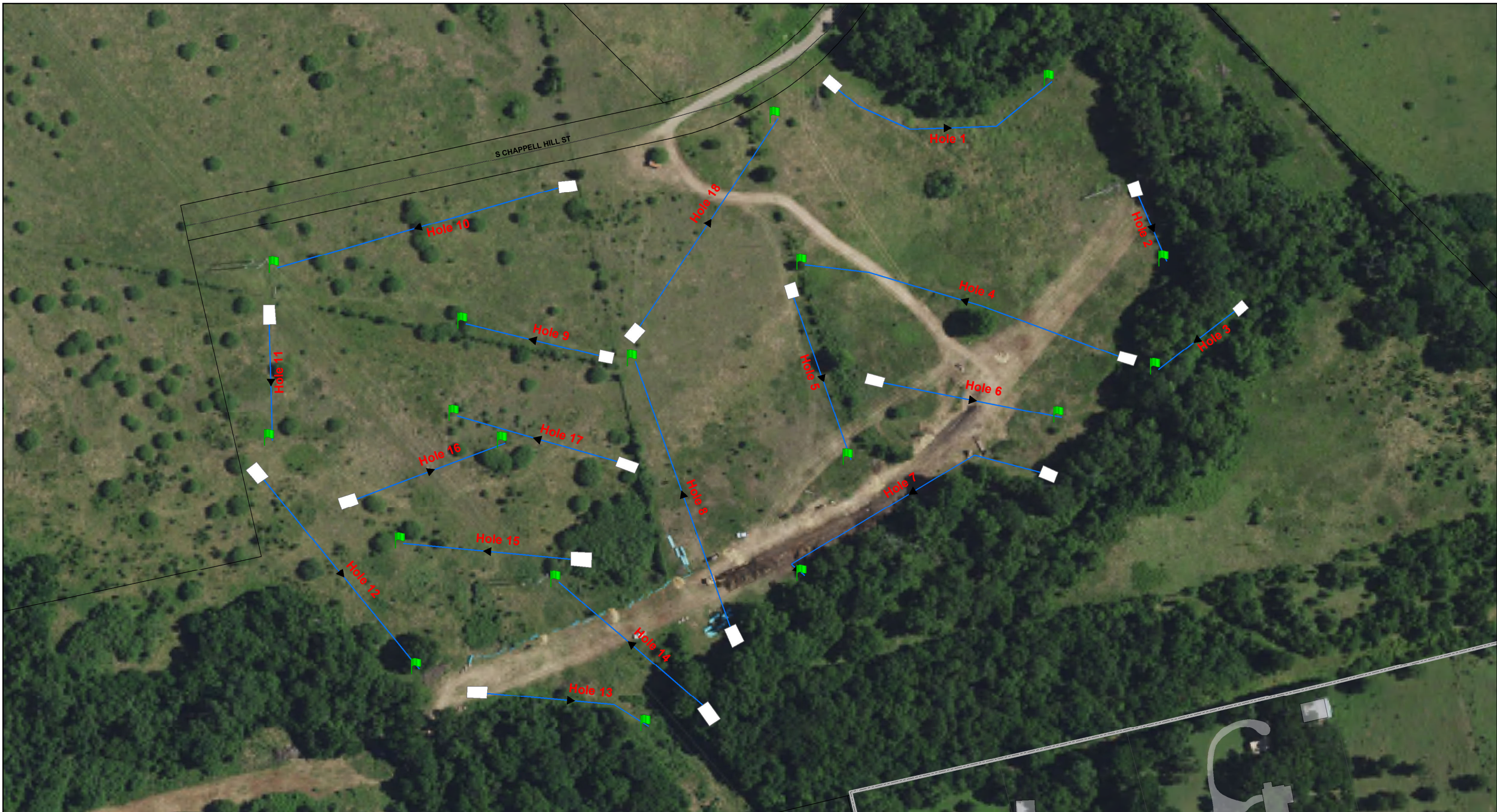
Over the last 20 yrs., we have had a 9-hole disc golf course at Hohlt Park which is located on the grassy hill above the parking lot facing N. Park St. As the amphitheater and restrooms were built along with the overflow of parking during athletic events this course has had its challenges and could be best suited elsewhere. With the large amount of acreage at the Brenham Family Park and our current plans to create a passive park starting with Phase 1A (35 acres) we have around 25 additional acres across the main creek on the southeast part in which are open, rolling terrain that will suit an 18-hole disc golf course nicely.

Over the past 4 months we have been meeting with local disc golf enthusiasts and laying out the 18 holes. In last years BCDC funding we were allocated \$26,000 to start transitioning from Hohlt to another location by purchasing new baskets, tee boxes and signage. We have purchased the baskets but as we move forward will ensure that the course plays as designed before tee boxes are poured and signs explaining the holes and coarse are installed.




We have had a lot of positive feedback from the local disc golf enthusiasts and are working hard to make this a destination not only for local users but to attract state-wide enthusiasts to come to Brenham and experience an 18-hole disc golf course. With the main creek crossing under construction and in hopes of getting the Brenham Family Park Phase 1A started in the Fall we feel this will be an awesome attribute to the southeast side of the park that will fit our passive park and not hinder walkers, be affected by vehicles and yet allow for a spacious area to really get out and sling the disc!

Attached you will see the area that we are working with and the layout of the 18-hole course. If for some reason this part of the park gets developed or changes usage on the back 70 acres

these could be easily moved and relocated but we intend that this will be an awesome place to expand the disc golf course until future development is decided.

**1. Bill Betts called the meeting to order** – welcome to our new board members Courtney Mason and Lauren Buth

**2. Citizen/Visitor Comments**

Vicki Bruce wanted to thank Tammy for promoting the Pickleball clinic and the city for all the support, 1<sup>st</sup> clinic had 23 out of 24 possible spots filled. Excited for the March event. There are over 100 members in the Brenham Pickleball club.

Dane – made a presentation to outgoing members Paul Buls and Jim Baker for their time served on the Parks Board.

**WORK SESSION**

**3. Discuss and Possibly Act Upon the Election of Chairperson and Vice-Chairperson for a Term of One (1) Year**

Elect the Chairperson and Vice-Chairperson for 2023. Electing the Chairperson and Vice-Chairperson is done annually. The term is for a one (1) year period per the Policies and Procedures for Boards and Commissions adopted by the City.

The Chairperson of the Board shall be the presiding officer for meetings, and the Vice-Chairperson shall act in the Chairperson's absence.

Bill asked for nominations from the board. Lee nominated Bill Betts for Chairman and Dusty Robinson seconded that nomination. Motion passed.

Dusty Robinson nominated Lee Chalmers for Vice Chairman, Courtney seconded the motion, motion passed.

#### **4. Presentation of the Texas Parks and Recreation Maintenance Rodeo & Workshop**

Dane Rau presented on the TRAPS Rodeo & Workshop. A PowerPoint presentation on the TRAPS Rodeo held on November 9-10<sup>th</sup>. All activities took place at Hohlt Park and the Barnhill Center. It was a great two days that was enjoyed by all and really showed the hard work that the City of Brenham has put into both Hohlt Park and the Barnhill Center. Over 30 different cities were represented throughout our region, and this was the first true "Breakout Workshop" in which the Barnhill Center hosted which utilized Morris Hall, Theatre, and Council Chambers. CONGRATS to Victor for placing 3<sup>rd</sup> in the plant identification category.

#### **5. Discussion Regarding Year End Tournament Recap**

Casey Redman presented a recap of end of year tournaments. Please see the attached 2022 tournament recap spreadsheet and the 2023 tournament booking list for your review. In 2022 – 35 tournaments made, 46 currently set for 2023. With more calling. Normally 70% make due to weather so normally 35 – 40 tournaments should make. Dane stated that those that have successful tournaments are the ones who have priority for the next year. BISD Boys Baseball only down for 1 tournament at home this year. We are also looking for part time help 17 yrs or older, mostly weekends, if anyone knows of someone please sent them our way.

#### **6. Discussion and Update Related to the Texas Parks and Wildlife Department (TPWD) Local Park Grant Program for Brenham Family Park and Recreational Trails Grant Program for the Nature Trail at Hohlt Park**

##### **Non-Urban Outdoor Recreation Grant for Brenham Family Park Phase I(a)**

Dane spoke on the Brenham Family Park, since our last update staff along with Quiddity and Wild Associates has re-submitted the Environmental Assessment to Texas Parks and Wildlife who subsequently has sent it to the National Parks Service for final approval. Based on the first round of recommendations from August of 2022 we feel that we have met all requirements related to archeological, environmental and design parameters. Quiddity has plans at 90% complete and we have also submitted them to our plan review team for comments. We have received a new timeline which is attached. We are anxious to receive the notice to proceed from the National Parks Service which is issuing the \$750,000 of grant funds to Texas Parks and Wildlife for this project. This is 32-33 acres consisting of all amenity playscape, parking lot, 1 mile hike/bike trail, 3-acre pond for fishing and kayaking.

In the meantime, we are proceeding with the Bridge Crossing that is located in the middle of Phase 1 and Phase 2 and will be needed not only for access to a lift station but long-term to connect the two sides. This was not part of the grant and was funded by BCDC. This will be maintenance crossing as well as pedestrian crossing. We are also actively working with the Disc

Golf Group to relocate the disc golf course from Hohlt Park to the south end of Phase 2 which will have a footprint of roughly 25 acres. This will allow them to have a more spacious coarse and 18 holes rather than 9. By adding this it will give another amenity to the Brenham Family Park until Phase 2 and 3 are developed more fully.

**Recreational Trails Program for Crossover Nature Trail**

Since last meeting we have successfully awarded this project to Collier Construction in the amount of \$291,517. Through Texas Parks and Wildlife we received a grant in the amount of \$66,400. The balance is funded by BCDC. The notice to proceed has been given to the city and construction should begin in February of 2023.

These improvements will include a boardwalk, educational signage, a 0.59-mile granite looped trail, benches, and numerous plantings that attract butterflies and pollinators. (See attachments) This will be known as the "Crossover Nature Trail".

We are excited to finally get this project off the ground and enhance this area of Hohlt Park for all. Project should be completed in June.

**7. Discussion and Update on Parks and Recreation Projects Funded in FY21-22**

Dane updated the board on the Board on BCDC funded items related to Parks, Recreation, and Aquatics. The team has completed all projects from 2021-22. Bridges Repainted at Henderson; Bullpen Upgrades at Hohlt Park; New Pay equipment at Hattie Mae Flowers; Parking Lot at the Aquatic Center; Nature Trail enhancements at Hohlt Park.

For the 2022-23 "New" projects our team is working hard to identify vendors, meet procurement policy and get applicable quotes to move forward. Some of the projects are much more intense such as the Men/Women Locker Room Refurbishment, Play for All Playscape and Turf Fields at Hohlt. Other projects are simpler, and we have already issued purchase and have even completed many of the projects.

The team is excited to enhance the Blue Bell Aquatic Center and City of Brenham Parks System and provide programming for our community through these dedicated funds. Dane - thanked the support of the Parks and Recreation Advisory Board and BCDC as it makes a huge difference and is noted by all.

Subject: Discuss and Possibly Act Upon a Memorandum of Agreement Between Blinn College and the City of Brenham For the Use of Soccer Fields at Hohlt Park.

Date: June 8, 2023

---

In 2018, Blinn College began their soccer program. At that time the City and Blinn entered into a 5 yr. agreement that allowed Blinn to use Rankin Field for home games/clinics and other fields at Hohlt Park for practices. The partnership has been a good one and since Brenham no longer plays soccer at Rankin field it puts usage onto Rankin Field and allows the city to receive reimbursement for usage.

Now that it is 2023 a new contract must be signed and agreed upon. There were some minor changes to the MOU which Casey, myself, Blinn and City Attorney, Cary Bovey approved of with the bulk of the agreement remaining the same as the original in 2018. The reimbursement for usage will start at \$26,500 for Rankin Field, practice fields and the use of a dressing/storage room. It will increase by \$1,000 each year capping out at \$30,500 in the year 2030. The original agreement ended at \$25,500 per year.

This will be presented to Brenham City Council on June 15<sup>th</sup> for approval. It has been a good partnership and we look forward to another 5 yrs.

We ask that Parks Board approve the MOU and we will relay the action taken by Parks Board to the Brenham City Council. If there are any suggested changes we can mention those as well.

**MEMORANDUM OF AGREEMENT  
BETWEEN BLINN COLLEGE AND THE CITY OF BRENHAM, TEXAS  
FOR THE USE OF SOCCER FIELDS AT HOHLT PARK**

Parties: City of Brenham, Texas (hereinafter also referred to as "City") and Blinn College (hereinafter also referred to as "College")

Recitals: Recognizing that cooperation is essential to provide first class intercollegiate soccer fields in the City and the College have agreed as follows:

1. Whereas, this Memorandum of Agreement (hereinafter referred to as "MOA") is Between the City and the College for the use of City soccer fields; and
2. Whereas, the City obtained land and constructed Hohlt Park (hereinafter also referred to as "Park") for the benefit of local residents; and
3. Whereas, within the Park, the City constructed several athletic fields for the use and enjoyment of athletic teams, including soccer fields ("Fields"); and
4. Whereas, the City maintains the Fields; and
5. Whereas, as consideration for its use of the Fields the College desires to compensate the City for a portion of the costs necessary to maintain the Fields;

NOW THEREFORE, the College and the City hereby agree to the following terms and conditions regarding the use and maintenance of the Field(s):

1. Recitals. The foregoing Recitals are hereby incorporated into this MOA between the parties for all purposes.
2. Term. This MOA shall be valid for a term of five (5) years beginning \_\_\_\_\_, 2023 and continuing through \_\_\_\_\_, 2028 unless earlier terminated by mutual consent of both parties or as otherwise set forth herein ("Term").
3. Compensation. On or before September 15<sup>th</sup> each year that this MOA is in effect, the College shall pay to the City the following amounts in accordance with the following schedule:

4. Use of Soccer Fields/Multi-Use Room (Soccer Side)
  - a. City agrees to provide the College the right to use Rankin Field located at Hohlt Park for its scheduled games during the Blinn Soccer season. The City also agrees that Blinn Soccer is authorized to utilize a practice field at Hohlt Park for practices during the intercollegiate soccer team's scheduled soccer season and during off-season. The use of one (1) multi-use room at Hohlt Park (Soccer Side) is also available to Blinn Soccer and may be used for daily storage of equipment and team meetings. The City reserves the right to use this multi-use room during weekend tournaments if needed, and the City's use will be communicated to Blinn Soccer prior to utilizing.
  - b. The City agrees to allow the College soccer program to utilize Rankin Field for fifteen (15) additional non-game days per calendar year for camps and tryouts. The specific dates for the additional days must be coordinated with the City's Parks Superintendent or his designee. No more than two (2) of the additional days can be on weekends.
  - c. During the College's intercollegiate soccer off-season and when not in use for scheduled games or practices during the Blinn Soccer season, the City retains its right to use the Fields for games, practices, tournament play, or any other use it deems appropriate.
  - d. As required by the City's Code of Ordinances, each organization which is approved by the City to use the Fields will be required to submit an annual refundable security deposit. This deposit rate has been set and approved by the City's Parks Advisory Board and the deposit rate will not change unless approved and modified by the Parks Advisory Board.
5. Maintenance of the Field. The City agrees to maintain the Fields in good order for use for intercollegiate soccer practices and games throughout the Term of this MOA. Maintenance of the Fields shall include maintenance of the lights within the Fields and the scoreboard along with striping and mowing of the field. The City will conduct litter and restroom duties each day prior to games at Rankin Field. When multiple games are played on the same day it is the responsibility of the College to perform litter control and stocking of the restrooms as supplies are needed. The City will supply the necessary items for these purposes. Speakers for the PA system at Rankin Field are the responsibility of the City

but it is the responsibility of the College to provide the PA system itself. During the Term of this MOA, should the College desire to construct, or request the City construct, any permanent improvements or additions other than routine maintenance it must be mutually agreed upon by both parties in writing prior to the commencement of any construction. The compensation setout herein is only for routine maintenance of the Fields. Funding for any permanent improvements, additions, or capital needs shall be agreed to in writing by both parties prior to commencement of any construction.

6. Contact Information. The parties to this MOA shall designate a contact person who will be responsible for implementing this MOA. The contact person for the City will be Casey Redman, Parks Superintendent or his designated representative. The City's Parks Superintendent can be reached at (979) 337-7235. The contact person for the College is Michael McBride, Head Soccer Coach / Division Chair. The College contact person can be reached at (979) 830-4922. Any notice required by this MOA shall be forwarded to each respective party at the following addresses:

7. Miscellaneous Provisions:
  - a. *Entire Agreement.* This MOA constitutes the entire agreement between the parties, including all covenants and agreements, between the parties with respect to the subject matter herein and supersedes any and all other agreements, either oral or in writing. Each party to the MOA acknowledges that no representation, inducements, promise or agreement, oral or otherwise, have been made by any other party or anyone acting on behalf of any party which are not embodied herein and that no other agreements, statement, or promise not contained in this MOA shall be valid or binding, unless a modification has been properly executed.
  - b. *Modification.* This MOA may be modified at any time by written agreement of the authorized representative of both parties. Such amendments will require the signatures of all parties affected by such an amendment.
  - c. *Cooperation.* The City and the College agree to cooperate with each other, in good faith, at all times during the term hereof in order to achieve the purposes and intent of this MOA. The City and the College

are separate governmental entities, and as such, are responsible for any injury, claim, or cause of action arising out of their participation or control of this MOA as may be provided by applicable law.

- d. *Termination.* Either party may terminate this MOA by giving written notice of intent to terminate upon at least 365 calendar days in advance of the effective termination date. Notice of termination shall be given to all parties covered by this MOA.
- e. *Invalid Provisions.* Any clause, sentence, paragraph, or article of this MOA which is determined by a court of competent jurisdiction to be invalid, illegal, or unenforceable in any respect shall not be deemed to impair, invalidate, or nullify the remainder of this MOA if the MOA can be given effect without the invalid portion.
- f. *Applicable Laws; Venue.* This MOA shall be construed in accordance with the laws of the State of Texas. Exclusive venue for any claim, cause of action, lawsuit, or other legal proceeding arising out of this MOA shall be in Washington County, Texas.

Each year, the staff is able to present and recommend various projects to both Parks Board and BCDC for funding opportunity. These funds are derived from sales tax proceeds that are spent locally and are geared to enhance the Parks and Recreation along with Aquatic amenities. We strive to have a mix of new amenities along with maintenance and upkeep of existing amenities which keeps our Parks System looking fresh and vibrant. We also take in account the Parks Master Plan and follow our goals and projects to the best of our ability.

Below you will see the requests that will be presented to BCDC in July. We are currently asking BCDC to consider 13 projects valued at \$1.15million dollars.

These projects were evaluated by Parks and Recreation Staff, Carolyn Miller and our budget team and prioritized based on need and future value to our parks system. Due to priority, budget and status of existing infrastructure these projects are our upmost importance.

Our largest project will be Jackson St Park Phase 1 Improvements which will help assist with upgrades to that park which could include but not limited to, restroom improvements, ADA upgrades, open air pavilion, larger walking/biking track and new playground amenities.

We would like feedback from Parks Board and ask for your support on moving forward with these enhancements.
