### Non-Urban Outdoor Recreation Grant for Brenham Family Park Phase I(a)

We have been in a holding pattern since May of 2023 with Texas Parks and Wildlife and the U.S Army Corps of Engineers as it relates to the Notice to Proceed for the Brenham Family Park Phase 1(a). The hold up was related to the classification and approval by the Corps of Engineers of stream classification and whether or not permits were needed for improvements to take place around the minor swales and ravines located on our site. In July, we were finally able to get 2 Core of Engineer project managers on-site to walk the property and show them the three areas of concern. We had a great site visit, and a lot of positive information was discussed between City staff, Quiddity engineers, Environmental Consultants and Corps of Engineer staff. On August 8<sup>th</sup> we received the letter from the U.S. Army Corps of Engineers that no permits were needed, and we were able to re-submit the EA. Staff immediately worked with Paul Wild, Environmental Consultant and re-submitted the EA to Texas and Parks and Wildlife who sent it over to the National Parks Service.

This was a huge step to get the “No permit required” letter from the Corps of Engineers and should put us in motion to receive the NTP by the end of year.

We are finalizing the main creek crossing which is 95% complete and looks great. Quiddity has the park plans at 90% design and has submitted them to the City for final review. Once we receive the NTP we will be able to wrap the design up and bid the project out based on the amenities that are listed in the grant which include parking lot, 1-mile of bike/walking trails, lake feature, lighting, benches, wildflower areas, etc. We have approximately \$1.5 million to begin Phase 1(a) and additional funds for an all amenity playscape.

We look forward to receiving our NTP and getting started with this project in 2024 or sooner. See attached letter from the U.S Army Corps of Engineers.

This letter is in regard to information received April 5, 2023, and subsequent submittals dated April 28, May 4, and July 31, 2023, concerning a proposal for the development of a family park located in the City of Brenham, Washington County, Texas. This project has been assigned Project Number SWF-2023-00181. Please include this number in all future correspondence concerning this project.

Under Section 404 of the Clean Water Act, the U.S. Army Corps of Engineers (USACE) regulates the discharge of dredged and fill material into waters of the United States, including wetlands. USACE responsibility under Section 10 of the Rivers and Harbors Act of 1899 is to regulate any work in, or affecting, navigable waters of the United States. Based on your description of the proposed work, a site visit conducted June 22, 2023, the figure entitled "Figure 6 Wetland Test Pit and Ordinary High Water Mark Map," and other information available to us, we have determined this project will not involve activities subject to the requirements of Section 404 or Section 10. Therefore, it will not require Department of the Army authorization pursuant to Section 404 and/or Section 10.

Staff would like to update the Board on several Capital Projects that were funded by BCDC in 2022-23. The two largest projects are finally designed and ready for bid.

**Turf Fields at Hohlt Park**

**Budget \$771,000**

This project had to be pushed back due to scheduling and making sure an engineered set of plans were designed so that all vendors had an opportunity to bid on alike quantities and specifications. We also had to make sure the least amount of impact was had while under construction pertaining to Little League and Select Tournaments. Plans have been finalized and Request for Proposals (RFP's) will be opened on August 29<sup>th</sup> by City personnel and CEI Engineers. We structured the scope of work so that we have some alternatives to consider, fearing that this project may go over the allocated amount of \$771,000. Once we open bids we will discuss how to proceed and discuss with BCDC our options. We are hoping to complete all 4 softball fields at Hohlt and work within the timeframe of November 13-Feb 2. We held a preliminary proposal meeting on August 15<sup>th</sup> and had 6 vendors at the meeting/walk -thru. We will keep you all posted once the RFP's are opened and scored.

This project details turf being installed on up to 4 softball infields at Hohlt Park along with several bullpen areas.

# Aquatic Center Locker Room Refurbishment

Budget \$208,000

BBA Architects has completed the plans for the refurbishment of the main restrooms and locker rooms at the Aquatic Center. These are approaching 23 yrs old and need a face lift. We will be opening Request for Proposals on September 26<sup>th</sup>. Improvements will involve updating showers, lighting, flooring, vanities, upgrading lockers, benches, and removing some walls along with replacing partitions. We have conducted the asbestos survey and all results came back good. We are hopeful to start in Nov/Dec and be complete within 90-120 days. We do expect these improvements to be over the \$208,000 but do have some options if this happens to consider with BCDC.

#### Parks Board Members

To update from the last meeting. We have made significant progress on the Disc Golf Course. All 18 course baskets have been assembled and installed by staff at each hole location. We do have 1 remaining basket to install as a “test basket” when you enter the course and that will be installed within the next few weeks. The fairways have been established with stakes and multiple shredding’s have taken place. As we continue to perform shredding and mowing, the fairways will become more defined, while allowing out of bounds areas to continue to produce natural wildflower growth areas as the park was intended to have.

We have been working closely with a small group of the disc golf community that have helped get the course into the current shape that it is at. This group has a better understanding of what makes a course go from good to great and what will draw as many people as we can in the disc golf world to Brenham. This group has been playing the course for several weeks now and have made the proper adjustments to allow the course to play as designed. It is laid out across all 25 acres and has a mixture of short par 3’s to long par 4’s.

Concrete Throwing pads or T-pads as the community calls them are currently in the works. The 18 locations have been established and site prep work is on the schedule. Once the creek crossing project is complete, we can get a concrete truck on location to pour each T-pad. We are looking to have this phase of the disc golf course completed before September.


As we continue making progress towards completion; signage will be the final step. The local disc golf group have already offered up their services and will fly the course with a drone and take aerial photos so we can have the course mapped as accurately as possible with tree lines, out of bounds lines, and the variety of hazards on the course. This will be a drawing on the sign and at each T-pad location. We will then be taking it one step further and having each hole flown from T-pad to basket. The goal with this is to then be able to provide a QR code on each

of the signs so that a new player can scan with their phone, and it will show them each hole from start to finish. This QR code can be printed on the sign along with the map drawing.

**1. Bill Betts called the meeting to order** – welcome to visitors and guests

**2. Citizen/Visitor Comments**

Vicki Bruce and Lisa Kessler wanted to inform the Parks Board of the influx of teens coming out to learn and play pickleball.

**WORK SESSION**

**3. Discussion and Presentation of Proposed New Location for Disc Golf Course at Brenham Family Park**

Dane Rau presented on the presentation for the new location for the disc golf course at the Brenham Family Park. Over the past 4 months we have been meeting with local disc golf enthusiasts and laying out the 18 holes. In last year's BCDC funding we were allocated \$26,000 to start transitioning from Hohlt to another location by purchasing new baskets, tee boxes and

signage. We have purchased the baskets but as we move forward will ensure that the course plays as designed before tee boxes are poured and signs explaining the holes and coarse are installed. Kyle Branham has taken the lead on this project.

We have had a 9-hole disc golf course at Hohlt Park which is located on the grassy hill above the parking lot facing N. Park St. As the amphitheater and restrooms were built along with the overflow of parking during athletic events this course has had its challenges and could be best suited elsewhere. With the large amount of acreage at the Brenham Family Park and our current plans to create a passive park starting with Phase 1A (35 acres) we have around 25 additional acres across the main creek on the southeast part in which are open, rolling terrain that will suit an 18-hole disc golf course nicely. Holes will be par 3, par 5's and will not take much maintenance to make this playable.

We have had a lot of positive feedback from the local disc golf enthusiasts and are working hard to make this a destination not only for local users but to attract state-wide enthusiasts to come to Brenham and experience an 18-hole disc golf course. With the main creek crossing under construction and in hopes of getting the Brenham Family Park Phase 1A started in the Fall we feel this will be an awesome attribute to the southeast side of the park that will fit our passive park and not hinder walkers, be affected by vehicles, and yet allow for a spacious area to really get out and sling the disc!

The area that we are working with and the layout of the 18-hole course. If for some reason this part of the park gets developed or changes usage on the back 70 acres these could be easily moved and relocated but we intend that this will be an awesome place to expand the disc golf course until future development is decided.

Kyle stated that the group of Disk Golf Groups is very active, pleasant group to work with. They just like Pickle Ball travel areas to play courses. This 18 hole course should attract visitors to our area as well. The plan is to keep the 9 hole course at Hohlt Park as a beginner course.

## **5. Discuss and Possibly Act Upon a Memorandum of Agreement between Blinn College and the City of Brenham for the Use of Soccer Fields at Hohlt Park**

Dane Rau presented on the presentation for the agreement between Blinn College & the City of Brenham use of the Soccer Fields at Hohlt Park. In 2018, Blinn College began their soccer program. At that time the City and Blinn entered into a 5 yr. agreement that allowed Blinn to use Rankin Field for home games/clinics and other fields at Hohlt Park for practices. The partnership has been a good one and since Brenham no longer plays soccer at Rankin field it puts usage onto Rankin Field and allows the city to receive reimbursement for usage.

Now that it is 2023 a new contract must be signed and agreed upon. There were some minor changes to the MOU which Casey, Dane, Blinn and City Attorney, Cary Bovey approved of with the bulk of the agreement remaining the same as the original in 2018. The reimbursement for usage will start at \$26,500 for Rankin Field, practice fields and the use of a dressing/storage room. It will increase by \$1,000 each year capping out at \$30,500 in the year 2030. The original agreement ended at \$25,500 per year.

This will be presented to Brenham City Council on June 15<sup>th</sup> for approval. It has been a good partnership and we look forward to another 5 yrs. We ask that Parks Board approve the MOU and we will relay the action taken by Parks Board to the Brenham City Council.

A motion was made by Board Member Courtney Mason and seconded by Board Member Tina Henderson to approve the agreement between Blinn College & the City of Brenham for the use of Soccer Fields at Hohlt Park. This agreement will be taken to City Council for final approval. All Board Members approved.

## **6. Discuss and Possibly Act Upon the Fiscal Year 2023-24 Funding Requests from the Brenham Community Development Corporation (BCDC) for Various Parks and Recreation Projects**

Dane Rau presented on the funding request from BCDC for various Parks and Recreation projects for the upcoming year. Each year, the staff is able to present and recommend various projects to both Parks Board and BCDC for funding opportunity. These funds are derived from sales tax proceeds that are spent locally and are geared to enhance the Parks and Recreation along with Aquatic amenities. We strive to have a mix of new amenities along with maintenance and upkeep of existing amenities which keeps our Parks System looking fresh and vibrant. We also take in account the Parks Master Plan and follow our goals and projects to the best of our ability.

Below you will see the requests that will be presented to BCDC in July. We are currently asking BCDC to consider 13 projects valued at \$1.15million dollars. These projects were evaluated by Parks and Recreation Staff, Carolyn Miller and our budget team and prioritized based on need and future value to our parks system. Due to priority, budget, and status of existing infrastructure these projects are our utmost importance.

Tammy talked about the 3 requests from the Aquatics department being the sound system for the facility originally to the building as it is not working in most of the facility. 3 single restrooms getting a facelift as they are original to the facility. Replacement parts are hard to find and replace when something breaks. The 3rd thing is the chemical doors and exterior door replacements. The Chemicals have eaten the interior door frames over the last 23 years, so replacing is a safety issue. Board Member Lee Chalmers suggested we look at composite doors. That is a metal door coated with a plastic exterior as they might hold up better and longer in our environment.

Casey then spoke about our park request. Our largest project will be Jackson St Park Phase 1 Improvements which will help assist with upgrades to that park which could include but not limited to, restroom improvements, ADA upgrades, open air pavilion, larger walking/biking track and new playground amenities. Hohlt Park restroom ventilations enhancements, Owsley playground surface repairs, turf mounds at Schroeder and Dallmeyer; Batting cage turf – phase 3 at fireman's and Henderson; Fireman's Kitchen wood door replacement, fireman's restroom floor refurbishment; story board panel upgrades replacing the temporary wooden frames to aluminum frames that will last for years to come, movies in the park, and sitting areas & benches for Owsley and Hattie Mae Basketball.

Dane stated that there was a donation made for concrete & improvements at Jackson Street on the Pickleball Courts, once the new budget year begins, we will start this project adding concrete and some benches. We would like feedback from Parks Board and ask for your support on moving forward with these enhancements.

Parks Board member Andrea Fischer asked if this was around the amount we normally ask for or if this was the wish list that we request and see what can be funded. Dane Rau stated that this was about the normal amount funded from the BCDC funding. This is a small percentage of the taxes that come in that are earmarked for our Parks and Recreation Department.
